### Official Information Act 1982 request

Thank you for your Official Information Act 1982 (OIA) request of 1 April 2019. Your request was clarified on 4 May 2019 for the following information:

Under section 182, 183 and 186 of the Crimes Act 1961 (relating to abortion), broken down by offence, by year and by ethnicity;

- 1. The total number of people arrested;
- 2. The total number of people charged;
- 3. The total number of people found guilty, including those who admitted the offences;
- 4. The total number of people convicted and
- 5. The total number of people sentenced.

Due to the small number of people charged and convicted of these offences each year, we are unable to provide the data broken down by year; this is to protect the identity of the people. We have provided totals for the entire period, 1980 to 2018.

In response to part 1 of your request, we are unable to provide you with the total number of people arrested for the offences of ss 182, 183, and 186 of the Crimes Act as the information you have requested is not recorded by the Ministry of Justice (the Ministry). Therefore, I am refusing your request as allowed by section 18(g)(i) of the OIA as there are no grounds for believing that the information is held by another department, Minister of the Crown, organisation, or local authority.

In response to part 2 of your request, refer to Table 1 attached. Please note that in some years no one was charged with an offence. In addition, some people might have been charged with multiple offences and in multiple years.

In response to part 3 and part 4 of your request, refer to Table 2 attached. Please note, 'people found guilty' and 'people convicted' of offences mean the same thing in the Ministry's Case Management System. We have interpreted 'found guilty' as receiving a 'proved outcome.' A proved outcome occurs where a person is found to be, or pleads, guilty. Proved outcomes include: convicted, Youth Court proved, discharged without conviction, adult diversion and Youth court diversion.

Please also find in response to part 3 of your request, for those who pleaded guilty to the offences, Table 3 attached to this response.

In response to part 5 of your request, refer to Table 4 attached. Please note that we have provided the total number of people convicted and imprisoned for any of the offences over the entire period from 1980 and 2018.

We are unable to answer the respondents questions as asked due to the small number of people charged and convicted of these offences each year. We have provided data for the entire time period (not by year) to protect the identity of the people charged/convicted.

- we have provided the total number of people charged with any of the offences by ethnicity. Q1 (arrests) - We are unable to provide data for Q1 (arrests) as this information is held by Police.
- Q2 (people chaged) we have provided the total number of people charged with multiple offences over the entire period from 1980 to 2018, In many years there were zero people charged. Some people may have been charged with multiple offences and/or in multiple years.
  we have provided the total number of charges and convided charges for each of the offence types instead, for their information.
  - Q3 (people pros note that we have not provided a table for his as there were only people convicted of these offences; there were zero people who received an outcome of Youth Court proved, discharge without conviction, adult diversion and Youth Court discharge.
- Q4 (people found guilty) we have interpreted being "found guilty" as receiving a "proved outcome". A proved outcome occurs where a person is found to be, or pleads, guilty. Proved outcomes include: convicted without conviction, adult diversion and Youth Court discharge.
- Q5 (people convicted) we have provided the total number of people convicted of any of the offences over the entire period from 1980 to 2018.

  we have provided the total number of people imprisoned for any of the offences by ethnicity.
- Q6 (people imprisoned) we have provided the total number of people convided and imprisoned for any of the offences over the entire period from 1980 to 2018.
- We have included an additional table (Table 4) to previously supplied which provide the total number of people who pleaded guilty to at leat one of these offences between 1990 and 2016.
