Tēnā koe Ms McIntyre

Thank you for your email of 12 April 2019, requesting information about prison visits and visitor applications. Your request has been considered under the Official Information Act 1982 (OIA).

Visits by whānau and friends are important to help prisoners maintain family and social relationships, and positive family support increases a prisoner's chance of successfully reintegrating into the community when they are released.

Prison visitors must apply to be an approved visitor of a prisoner. This includes all children under 18 years of age. People who want to visit must first fill out a visitor application form, which is followed by security checks.

Visits must be booked in advance. Visiting hours vary across all prisons, and generally depend on which unit the prisoner is in. In some circumstances, special visits can be arranged, for example, family visiting from overseas or due to the bereavement of a loved one.

You have requested:

- 1. The total number of prison visits per annum, as far back as records permit.*
- 2. The total number of prison visits per annum broken down by facility, as far back as records permit.*

Corrections started collating data relating to the number of prison visits in 2000. The information you have requested is provided as Appendix One.

3. *The total number of visitor applications per annum, as far back as records permit. Please break this down by outcome of applications (i.e. successful, declined, etc.).*

Corrections changed the way it recorded this data in 2007. Therefore we are only able to provide data for the period 2008 to 2018. This is attached as Appendix Two.

4. *The total number of people currently registered as approved visitors.*

The information you request does not currently exist in a form that can be readily supplied to you, and would instead require initiation of a project to extract, analyse and present the data in the form requested.

Therefore, this part of your request is declined under section 18(g) of the OIA, as the information requested is not held by Corrections, and we have no grounds for believing it is held by another agency or is more closely connected with the functions of another agency.

Please note the Ombudsman has advised that information is not considered to be held by an agency in instances where a request necessitates research or analysis of source data in order to generate fresh information in a form different from that in which the base data is held.

I trust the information provided is of assistance. Should you have any concerns with this response, I would encourage you to raise these with Corrections.
