Thank you for your email of 3 May 2019, requesting information about offenders. Your request has been considered under the Official Information Act 1982 (OIA).

You requested:

- 1. For each calendar year, how many offenders each year completed their prison sentence and were released.
- a. Of these offenders, how many were completing a sentence which was for an offence for which they received a first strike under the Sentencing and Parole Reform Act 2010
- b. Of these offenders, how many were completing a sentence which was for an offence for which they received a second strike under the Sentencing and Parole Reform Act 2010
- c. Of these offenders, how many were completing a sentence which was for an offence for which they received a third strike under the Sentencing and Parole Reform Act 2010

Please refer to Appendix One for the requested information. Please note that these numbers include people who have been either released on conditions on their statutory release date, or released on parole.

- 2. For each calendar year how many offenders who were released have since been convicted of a new imprisonable offence.
- a. Of these offenders, how many had previously served a sentence for which they received a first strike.
- b. Of these offenders, how many had previously served a sentence for which they received a second strike.
- c. Of these offenders, how many had previously served a sentence for which they received a third strike.

Please refer to Appendix Two. Corrections does not record all offences which individuals have been convicted of into 'imprisonable' and 'non-imprisonable' categories. The figures provided show the number of people who were convicted of any new offence that resulted in a new sentence administered by Corrections. This includes both sentences of imprisonment and community-based sentences. Please note that those released in earlier years have experienced a longer period within which to be reconvicted. As a result, it may not be helpful to compare rates of reconviction of those released across different years.

- 3. For each calendar year how many offenders who were released have since been convicted of a new non-imprisonable offence.
- a. Of these offenders, how many had previously served a sentence for which they received a first strike.
- b. Of these offenders, how many had previously served a sentence for which they received a second strike.
- c. Of these offenders, how many had previously served a sentence for which they received a third strike.

Please refer to Appendix Three for this information. Please note that these numbers show those released who were then convicted of a new offence and received a new sentence not administered by Corrections. This could include those who received a fine, a driving disqualification or a reparation order.

To calculate the figures provided, we calculated the difference between the number of convictions received and the number of Corrections administered sentences received. Therefore, the figures in this table relate to those who were convicted of an offence but did not receive a Corrections administered sentence as a result.

- 4. For each calendar year how many offenders who were released have since been re-imprisoned for breach of bail conditions or terms of release.
- a. Of these offenders, how many had previously served a sentence for which they received a first strike.
- b. Of these offenders, how many had previously served a sentence for which they received a second strike.
- c. Of these offenders, how many had previously served a sentence for which they received a third strike.

Please refer to Appendix Four for this information. Please note that this information does not include 'breach of bail conditions', as this is not an offence that can result in imprisonment. If someone breaches their bail conditions, they may then be held in custody on remand pending their court hearing, rather than remaining in the community on bail.
