Thank you for your official information request received on 7 May 2019 for:

- how much LINZ has spent (and contracted to spend) on consultants (i.e. nonpermanent employees) over the past two financial years
- copies of all written material that explains the scope and role of any consultant's roles and project, the total figures by sub-department and project, and total estimated cost for each project
- copies of all written material that shows the department (and sub-department)'s ordinary operational expenditure.

How much has LINZ spent on contractors and consultants

The table below outlines LINZ contractor and consultant spend over the last two audited financial years.

Scope and role of any consultant's roles and project:

Each year, LINZ completes an Annual Review on its operating performance and reports this information to Select Committee. The Annual Review includes publicly available information on LINZ contractors and consultants spend. This information includes contractor name, type of service provided, specific purpose, sum of amount, rate, contract date, date commenced and completion date, tenders invited, and explanation if not tendered.

This information is prepared in accordance with the State Services Commission guidance to enable state services agencies to consistently measure and report their usage of contractors and consultants.

Section 16(1) of the Official Information Act 1982 provides LINZ with the ability to provide documents in the form of a summary. In relation to your request for "copies of all written material that explains the scope and role of any consultant's roles and project" we advise that we have summarised this information in Appendix 1 and Appendix 2 as providing copies of all the written material would require a substantial collation of information.
