Dear Ti

I refer to your request of 16 May 2019, under the Official Information Act 1982 (OIA), for the following:

Please provide me with the snapshot population of all NZDF detention facilities on the final day of each quarter, as far back as records permit. In other words, please provide me with the number of people in all NZDF detention facilities on March 31, June 30, September 30, and December 31 of each year, as far back as records permit.

Please break this down further by ethnicity and gender of the population.

As far as I understand it, the only NZDF detention facility is the Services Corrective Establishment (SCE) at Burnham Military Camp. Please let me know if there are other detention facilities and, if so, please break down the snapshot population by facility.

There is only one New Zealand Defence Force (NZDF) detention facility: the Services Corrective Establishment (SCE) at Burnham Military Camp, as referred to in your request. The number of personnel detained at the SCE, their gender and their ethnicity, is readily retrievable back to 2014, and this has been provided in this response. To provide the requested data prior to this date would require manual cross-referencing across different sources of data (including information held in hardcopy files). Please note that ethnicity is a self-declared optional step during the enlistment process. Personnel can select up to three ethnicities (this response reflects the primary ethnicity selected), and are free to update this information at any time.

Two sets of data are enclosed. The first provides the requested quarterly snapshot as specified, on the last day of March, June, September and December. NZDF personnel are typically detained for short periods of time only, however, therefore these snapshots do not provide a complete representation. The second enclosure provides the number of personnel detained during each quarter, noting an individual detainee is only counted once, in the quarter their detention began.

You have the right, under section 28(3) of the OIA, to ask an Ombudsman to review my response to your request.
