4Q was completed at the address on the 17/07/2019:

This is a jointly owned property with 4x dwellings and 2x sheds.

The dwelling to the left is occupied by the JOHNSON family who brought into the property about 3 years ago. They also have ownership of a double garage next to their dwelling.

In the middle is a small dwelling that is jointly owned by both parties which they are suppose to both maintain. This is usually used for guests.

The 2 story dwelling to the right is occupied by MR SKYRME who is 75years of age and has been residing at the property for the past 34 years. He has 2 sheds to the right hand side of his dwelling.

There have been multiple incidents between the households over petty matters. Now that these matters are starting to surface things have begun to escalate.

A lot of this is due to a communication break down between the two house holds.

SKYRMES was spoken to and gave his version of events.

Considering his age SYKRMES is an intelligent man who is living on his own. He is very independent and his sense of humour could be misunderstood or considered insulting to others at times.

He stated that he had friends that wanted to purchase the property and when that fell through his daughters suggested that he put in an offer which they would financially support him with.

He put in a starting offer which was obviously declined. The bank then requested that photos be taken of the property to give them more of an idea of its value. So SKYRMES went over to the JOHNSONS and started taking photos.

A trespass notice was served and happily accepted by SKYRMES.
