Tēnā koe Ti

Thank you for your email of 6 August 2019, requesting information about prisoners charged with a misconduct under section 128(1)(k) of the Corrections Act 2004. Your request has been considered under the Official Information Act 1982 (OIA).

Corrections has a zero tolerance policy toward offences against the good order and safety of prisons. Our staff recognise the importance of knowing and understanding prisoners, and actively engage with them to reinforce positive behaviour. Where a prisoner has seriously or repeatedly misbehaved in spite of efforts by staff to encourage them to behave appropriately, staff are able to charge the prisoner with an internal misconduct.

In accordance with the Corrections Act 2004 (the Act), there are a number of offences for which a prisoner may be charged with an internal misconduct. These include:

- disobeying a lawful order from an officer or other staff member
- behaving in an offensive, threatening, abusive or intimidating manner
- assaulting or fighting others
- deliberately damaging prison property

Section 128(1)(k) of the Act relates to occasions when a prisoner combines with other prisoners for a purpose that is likely to endanger the security or good order of the prison. This can include any behaviour from a group of prisoners refusing to return to their cells (known as "propping") through to rioting.

Staff are encouraged to report every occasion where a prisoner acts inappropriately. This ensures that prisoners are held responsible for their behaviour, either through referral of the incident to Police, or the internal misconduct system, and that their security classification is appropriate.



All misconducts are heard by an impartial hearing adjudicator or Visiting Justice to ensure they are handled fairly. If a prisoner is found guilty of (or pleads guilty to) non-compliance with the rules and regulations of the prison, they are sanctioned in a just and humane manner. If the prisoner pleads or is found guilty, the hearing adjudicator or Visiting Justice determines the appropriate sanction, which can include loss of privileges, forfeiture of earnings, or cell confinement.

Our policy about charging prisoners with misconducts is recorded in the Corrections Prison Operations Manual. This includes policy on filing a disciplinary charge, misconduct pre-hearings, misconduct hearings and penalties, and the appeals process. When reviewing this response, please note that on some occasions, an offender may be charged with a misconduct in one calendar year, but not found guilty until the following year.

You requested:

- 1. Please provide me with the total number of charges under s 128(1)(k) of the Corrections Act ("combines with other prisoners for a purpose that is likely to endanger the security or good order of the prison") per annum as far back as records permit. Please break this down by:
 - -ethnicity of the charged person; AND -corrections facility.

Please find this information attached as Appendix One.

With reference to the figures in the appendices, for privacy reasons in accordance with Statistics New Zealand guidance, where counts of 1 or 2 are recorded in the data, the number has been rendered as '3' throughout the response.

Please note that ethnicity information is self-reported by prisoners, and is not confirmed or verified by Corrections staff. Furthermore, prisoners may identify with more than one ethnicity. However, only their 'primary' ethnicity is reported.

- 2. Please provide me with the total number of people found guilty of an offence under s 128(1)(k) of the Corrections Act ("combines with other prisoners for a purpose that is likely to endanger the security or good order of the prison") per annum as far back as records permit. Please break this down by:
 - -ethnicity of the charged person; AND
 - -corrections facility.

Please find this information attached as Appendix Two. For your convenience we have provided this information both as the number of misconduct charges and the number of individual offenders.

- 3. Please provide me with the total number of people found guilty of an offence under s 128(1)(k) of the Corrections Act ("combines with other prisoners for a purpose that is likely to endanger the security or good order of the prison") AND sentenced to cell confinement (under ss 133(3)(c) and 137(3)(c) of the Corrections Act), per annum as far back as records permit. Please break this down by:
 - -ethnicity of the charged person; AND -corrections facility.

Please find this information attached as Appendix Three. As above, for your convenience we have provided this information both as the number of misconduct charges and the number of individual offenders.

I trust the information provided is of assistance. Should you have any concerns with this response, I would encourage you to raise these with Corrections.
