CLASS 4 VENUE LICENCE

Pursuant to section 67 of the Gambling Act 2003 (the Act), the Secretary for Internal Affairs (the Secretary) hereby grants a class 4 venue licence to:

AVONDALE RETURNED SERVICES ASSOCIATION INCORPORATED (the corporate society)

authorising it to conduct class 4 gambling by way of gaming machines at the following venue for the sole objective of applying and/or distributing the net proceeds from the gambling to or for the following authorised purpose(s):

1. PROVISION OF WELFARE ASSISTANCE TO NEEDY MEMBERS OR THEIR DEPENDANTS THROUGH GRANTS OR ASSISTANCE WITH FUNERAL EXPENSES, HOSPITALISATION, CONVALESCENCE, HEALTH AIDS AND THE LIKE.
2. PAYMENT OF CAPITATION FEES TO THE NZRSA, NZCCA AND ACTUAL AND REASONABLE EXPENSES INCURRED THROUGH EXECUTIVE MEMBERS' ATTENDANCE AT CONFERENCES RELATED TO CLUB BUSINESS.
3. GRANTS TO RECOGNISED CHARITABLE ORGANISATIONS SUCH AS PLUNKET OR RED CROSS, AND TO AMATEUR SPORTING AND BONA FIDE YOUTH ORGANISATIONS WITHIN THE LOCAL COMMUNITY TO FURTHER THE OBJECTIVES OF THESE GROUPS. NO DONATIONS AND/OR PAYMENTS TO PROFESSIONAL SPORTSPERSONS.
4. ASSIST SPORTING ADJUNCTS WITHIN THE CLUB THROUGH PROVISION OF UNIFORMS, EQUIPMENT, PREMISES AND ACTUAL AND REASONABLE EXPENSES TO TRAVEL TO AND COMPETE IN TOURNAMENTS WITH KINDRED GROUPS.
5. ASSISTANCE WITH THE COSTS OF ANZAC AND POPPY DAY COMMEMORATIONS, EXCLUDING PROVISION OF ALCOHOL, FOOD OR ENTERTAINMENT. PURCHASE OF MEMORABILIA AND PLAQUES, AND COSTS FOR MAINTAINING THE CEMETERY.
6. FUNDS TO ASSIST WITH THE PURCHASE AND MAINTENANCE OF A CLUB VEHICLE TO BE USED FOR CLUB BUSINESS E.G. TRANSPORTATION OF CLUB MEMBERS TO COMPETE IN SPORTING EVENTS, WELFARE PURPOSES ETC. THE VEHICLE CANNOT BE USED FOR PRIVATE OR PERSONAL PURPOSES.
7. WAGES OR SALARIES OF STAFF WHOSE POSITION IS ENTIRELY DEDICATED TO SUPPORTING THE NON-COMMERCIAL PURPOSES OF THE RSA. EXCLUDES BAR STAFF.

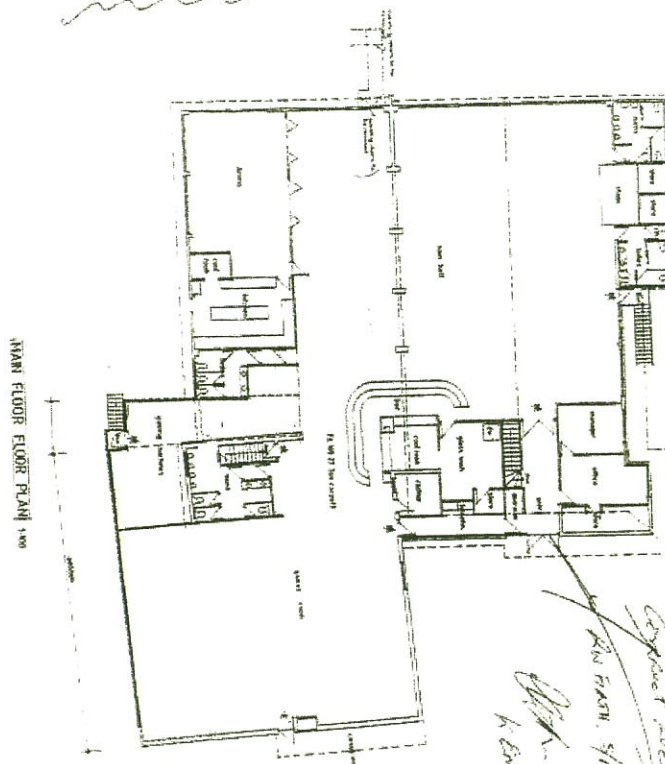
