

Club Licence

Section 21, 64 and 135, Sale and Supply of Alcohol Act 2012



007/CLUB/9014/2015

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **New Zealand 'All Golds' Cosmopolitan Club Inc** (the licensee) is authorised to sell and supply alcohol on the premises situated at **2-48 Ash Street, Avondale, Auckland** and known as **New Zealand All Golds Cosmopolitan Club**, for consumption on the premises, to any person who –

- (a) is a member of the club; or
- (b) is on the premises at the invitation of, and is accompanied by, a member of the club; or
- (c) is a member of some other club with which the holder of the licence has an arrangement for reciprocal visiting rights for members.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- (a) The following steps must be taken to ensure that the provisions of the Act relating to the sale of alcohol to prohibited persons are observed:
 - (i) Ensure that no intoxicated persons are allowed to enter or to remain on the premises
 - (ii) Ensure that appropriate signs are prominently displayed detailing the statutory restrictions on the supply of liquor to minors and intoxicated persons, adjacent to every point of sale.
- (b) **Alcohol must be sold only on the following days and during the following hours:
Monday to Sunday 9.00am to 1.00am the following day**
- (c) Drinking water is to be freely available to customers while the premises are open for business and signage directing people to drinking water must be prominently displayed on the premises.
- (d) The fees payable for the licensing of the premises concerned are the following risk rating: Very Low
- (e) The following steps must be taken to promote the responsible consumption of alcohol:
 - (i) The licensee must ensure that all staff comply with the host responsibility plan submitted with the application for an on-licence detailing the steps to be taken by the licensee to ensure a safe drinking environment.
- (f) The whole of the premises are undesignated.
- (g) Food must be prominently advertised within the premises

DURATION

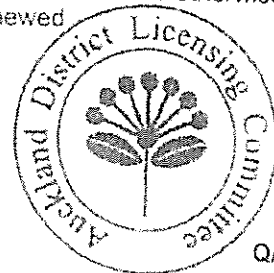
Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force—

- (a) until the close of the period for which it was last renewed; or
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, until the close of the period of 3 years after the period for which it was last renewed
