## Dear Jacob Bobby E

- Total number of Partner of a New Zealander visitor visa applications received in December 2018, January, February and March 2019 by INZ Mumbai. Please provide numbers for each month.
- 4. Of the total number of Partner of a New Zealander visitor visa applications received in December 2018, January, February and March 2019 by INZ Mumbai, how many have been processed as of today? Please provide numbers for each month.
- 5. The exact date until which partnership based visa application processing has completed.
- 6. Total number of trained immigration officers available in INZ Mumbai to handle partnership based visa applications, as of today.

We contacted you by email on 10 September 2019, 11 September 2019 and 12 September 2019 to clarify your request. We received your response by email on 10 September 2019 and 11 September 2019 which amended your request as follows:

 The Partner of a New Zealander visitor visa applications that INZ Mumbai has received in the month of February 2019, until which date have they completed allocating to an Immigration Officer.

As of 12 September 2019, the date of the oldest unallocated application lodged as a Visitor Visa, Partnership, on hand in INZ Mumbai and tendered in February is 25 February 2019.

6. Total number of trained immigration officers available in INZ Mumbai to handle partnership based visa applications, as of today.

As of 7 September 2019, INZ had 8 trained immigration officers in the INZ Mumbai office who are able to assess partnership applications. INZ Mumbai have a further 23 immigration officers in training all of whom will be fully trained by 23 September 2019.

7. Do you have plans to increase the number of immigration officers that will handle partnership applications currently handled by INZ Mumbai?

Yes, 5 additional immigration officers will be assessing partnership applications from 16 September 2019. A further 18 additional immigration officers will be assessing partnership applications from 23 September 2019.
