## Dear Harry Robson

On 18 September 2019, you contacted the Department of Prime Minister and Cabinet (DPMC) requesting the following information under the Official Information Act 1982 (the Act):

- 1) How many meetings have the PM and Cabinet had with theistic leaders and theistic organisations since October 2017?
  - a) Which leaders and organisations have been met with? How many times were said leaders and organisations met with?
  - b) How long were these said meetings?
  - c) What was discussed during said meetings?
  - d) Did said meetings impact on any governmental action (including policy and legislation)?
- 2) Has the PM or members of Cabinet ever met with "The Family and International Foundation" (USA) or communicated with them, in any capacity (including indirectly)?
  - a) How long were these said meetings? Who was involved in and with them?
  - b) What was discussed during said meetings?
- 3) Does the PM or Cabinet have any protocols regarding the separation of church and state?

Parts one and two of the request are for information that is held by the Prime Minister and all Cabinet Ministers. Accordingly, DPMC has decided under section 14(b)(i) of the Act to transfer these parts of the request to Cabinet Ministers.

In response to parts 1(a), 1(b), and 1(c) of your request, I have provided a table of my meetings with theistic leaders and organisations from October 2017 to 18 September 2019 at **Appendix A**. Please note that I have excluded ethnic or multicultural events, including celebrations that I attended, such as community celebrations of Chinese New Year or Diwali. In relation to part 1(c), I have provided the purpose of each of the meetings listed as my office does not keep an exhaustive list of what was discussed during such meetings.

In addition, I meet with community leaders and organisations established to work for faith groups that promote a religion and carry out social cohesion work. These organisations include the Federation of Islamic Association of New Zealand, Islamic Women's Council of New Zealand and the Hindu Council of New Zealand. For further information, my ministerial diary is published every month and can be found on the Beehive website www.beehive.govt.nz.

Regarding part 1(d) of your request, the meetings listed at Appendix A have not resulted in any specific New Zealand Government policy or legislation. However, these meetings contributed to the Office of Ethnic Communities' overall work of improving knowledge and understanding ethnic diversity and inclusion in New Zealand.

In relation to the entirety of part two of your request, I have not met with any representatives from The Family and International Foundation (USA).
