I refer to your request received on 27 September 2019, which has been considered under the Official Information Act 1982 (OIA), for the following information:

"...communication between the Waitematā Board and the Ministry in relation to the Proposed National Erebus Memorial."

In response to this request, the Ministry has searched for and collated all emails and letters sent to or from the Waitematā Local Board. This reflects substantive correspondence with the Waitematā Local Board. Please note that much of the email correspondence is from Auckland Council email addresses. This reflects the fact that under the Local Government (Auckland Council) Act 2009, local boards do not have separate legal standing from Auckland Council. We have treated your request as relating to Waitematā Local Board members and staff whose roles relate to that Board.
