Our response

The table below shows the number of Skilled Migrant Category applications received from November 2018 to September 2019.

The number of applications allocated for each month within this time period is being refused under section 18(f) of the OIA – that the information requested cannot be made available without substantial collation or research. To provide you with this information would require staff to manually review each file recorded in the table below. Providing this information would remove Ministry staff from their core duties and therefore the greater public interest in the effective and efficient administration of the public service would not be served. I have considered whether the Ministry would be able to respond to your request given extra time or the ability to charge for the information requested. I have concluded that, in both cases, the Ministry's ability to undertake its work would still be prejudiced.
