This information is released to you under the Official Information Act 1982. Where appropriate to protect the privacy of persons, names of officials have been withheld under section 9(2)(a) of the Official Information Act (the Act).

Ministry Précis notes for Pre Cabinet meetings are withheld under the following provisions of the Act:

- section 9(2)(f)(iv) to maintain the constitutional conventions for the time being which
  protect the confidentiality of advice tendered by Ministers of the Crown and officials; and
- section 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of any department or organisation in the course of their duty.

For MPI Briefing B12-699 *Meeting with Hawke's Bay Regional Investment Company re Irrigation Investment* I have withheld paragraphs 31 and 32 under section 9(2)(b)(ii) of the Act on the grounds that disclosure would unreasonably prejudice the commercial position of the person who is the subject of the information.
