## Ruataniwha Water Storage Proposal

Thank you for your letter of 1 November 2012 in which you indicate an intention to lodge RMA applications for the Ruataniwha Water Storage Proposal directly with the Environmental Protection Authority (EPA). We have also received a letter from Hawke's Bay Regional Council (HBRC) indicating its intent to request that the Minister for the Environment call in the Proposed Tukituki Plan Change, which is scheduled to be notified in the coming months, and note that you consider that these proposals should be processed together.

This letter is to confirm that the EPA will now begin to cost recover all actual and reasonable costs associated with the Ruataniwha Water Storage Proposal.

Section 149ZD of the Resource Management Act 1991 (RMA) allows the EPA to recover actual and reasonable costs incurred by the EPA both prior to a matter being lodged and following the lodgement of a matter with the EPA in exercising its functions and powers under the RMA. This includes any costs in respect of secretarial and support services provided to a board of inquiry, and in respect of making resommendations to the Minister for the Environment on applications.

The EPA has developed a cost recovery policy to provide guidance on when actual and reasonable costs will be recovered. The EPA only seeks to recover costs that arise from providing advice at the request of a potential applicant, or through undertaking work required following the lodgement of an application by an applicant. Costs arising from this are seen as primarily benefitting the applicant. EPA activities which benefit the wider community rather than the applicant are not recovered. The current cost recovery policy is attached for your information.

Section 357B provides a right of objection in relation to the recovery of costs by the Minister for the Environment

Can you please confirm by 9 November if these costs should be invoiced together with costs associated with HBRC's Proposed Plan Change, and who should be invoiced

#### Ruataniwha Water Storage Proposal

The EPA has received letters of intent from Hawke's Bay Regional Council (HBRC) and Hawke's Bay Regional Investment Company Ltd (HBRIC) for matters relating to the Ruataniwha Water Storage Scheme (RWSS). HBRC has indicated that it intends to request that the Minister for the Environment call in the Proposed Tukituki Plan Change which is scheduled to be notified in the coming months HBRIC has indicated that it intends to lodge Resource Management Act (RMA) applications associated with the development of the RWSS. These matters, together known as the Ruataniwha Water Storage Proposal, are likely to be lodged in early 2013

#### National significance

After lodgement, the Minister for the Environment decides whether the proposal is (or is part of) a proposal of national significance, and it so, directs the matter to a board of inquiry, the Environment Court, or the relevant local authorities for a decision.

In making her direction, the Minister must have regard to the views of the local authorities and their capacity to process the matter under section 147(4)(a) and (b) of the RMA.

On behalf of the Minister, we formally seek the views of the HBRC on:

- whether the matter should be referred to a board of inquiry, the Environment Court or the local authority; and
- the Council's capacity to process the matter.

# Board of inquiry nominations

Should the Minister direct the matters to a board of inquiry, the Minister must also seek the local authorities' suggestions for members of the board under section 149K(2) of the RMA. Please provide suggestions for members of a board of inquiry, including their names and if available, the contact details and curriculum vitae of nominated board members.

Relationship Protocol and Services Agreement

If the proposal is directed to a board of inquiry, Part 6AA of the Resource Management Act requires that the EPA engage the relevant local authorities to prepare a section 149G(3) 'Key Issues' report. There are other pieces of work that the EPA may wish to engage HBRC to undertake including assessing the completeness and adequacy of any application against Council plans and providing information relating to notification of landowners and occupiers.

The EPA has a standard 'relationship protocol,' developed with a number of local authorities, that records how a local authority and the EPA will work together as each performs its own statutory functions and other roles under Part 6AA of the RMA. Under this relationship protocol sits a 'services agreement', which sets out the services that the EPA may request from the Council, and individual statements of work, which are agreed on when services are requested.

We would like to commence a process to agree with your council a Relationship Protocol and Services Agreement before the HRBC and HBRIC applications are progressed so that we may be prepared for when the time comes to work together.

A draft Relationship Protocol and Services Agreement are attached to this letter. Please:

- Read the draft Relationship Protocol and Services Agreement and confirm that you agree to the terms or, alternatively, provide comments and suggested amendments.
- Provide the contact details of the person within your council who will act as the contact for this
  proposal and to be entered into the Relationship Protocol.

We will arrange for final versions of the Relationship Protocol and Services Agreement to be signed by the EPA, and then sent to you for final signing.

We are happy to discuss any issues or concerns you may have, before we agree and sign a final version.

#### Further information

We would appreciate a response on the above matters by 9 November 2012. Following your response we will seek to meet with Council representatives as soon as possible. In addition, we would appreciate the Council's formal views on the matters discussed on the first page of this letter by 21 December 2012.

# Tukituki Catchment Proposal - confirming estimated budget

### Dear Stephen

As per our recent telephone conversation twould like to confirm the budget estimate for the Tukituki Catchment Proposal. We have calculated a budget estimate of \$\sume9(2)(b)\$ based on the following assumptions:

- A Board of Inquiry will consist of 5 members
- The Retired High Court Judge rate has been used to calculate the honorarium for the Board Chair
- \$650 per day has been allowed for an Environment Commissioner
- \$800 per day has been allowed for the remaining BOI members given standing exemption approved by Cabinet
- The hearing will be held in Hawke's Bay
- The decision writing will be done in Hawke's Bay
- The number of submissions will be in the low hundreds
- The hearing will be 4 weeks (dependent on a range of factors)
- The cost of accommodation will be \$150 per board member/staff member per day
- The cost per day for breakfast and dinner will be \$90 per board member/staff member per day
- Two EPA staff will travel to the hearing and attend for the duration. A third EPA staff member will attend the hearing for a day each week for set up and support
- Flights will cost approx \$540 per person return for both board and staff (this is based on approximate flight costs from Wellington to Hawke's Bay)
- One board member will be local and won't require flights

- Approx \$20 per board member per day has been allowed for taxi fares during hearing and decision writing
- Catering will be approximately \$100 per day during hearing and deliberations
- EPA staff will provide hearing manager services
- The Board's technical experts will be available during conferencing and parts of the hearing. As we discussed the number of submissions, the number of people wishing to be heard and the number of outstanding matters a board must consider are key determining factors in the length of the hearing and consequently the budget. During our discussion we agreed that based on the consultation HBRC has already done it is reasonable to expect submission numbers to be in the low hundreds and the hearing to run for approximately 4 weeks. However, should the proposal prove to be more controversial, resulting in more submissions and a longer hearing, we will have to adjust the budget accordingly.
