## Local Government Official Information and Meetings Act 1987 (LGOIMA) CAS-10590-X2F4Q3 – Glen Innes to Tamaki Drive Project

We refer to your request for official information dated 17 October 2019 regarding the funding for the Glen Innes to Tamaki Drive project.

We acknowledge that the initial timeframe for the four sections of the Glen Innes to Tamaki Drive Shared Path project was 2015 – 2018, and that delays can be quite frustrating.

As work on the project has progressed there have been significantly more design and construction challenges than were first anticipated, coupled with a change of route for Section 4.

The AT Board has principally agreed at the board meeting held on 3 December 2019 that the Glen Innes to Tamaki Drive Shared Path project sections 2 and 4 (remaining sections) will be funded and delivered by AT and NZTA.

We anticipate that a final funding decision will be made by the end of March 2020. Once a final decision is made, we will advise key stakeholders and members of the public.

We are focussed on getting section 2 construction ready so that if we are granted the necessary funding we can get started without delay. The same is happening on Section 4, and preparation to lodge for resource consent is underway.

This week NZTA are issuing a Registration of Interest for Section 2 of the project to identify potential construction partners. Formal procurement is subject to Board approvals and securing funding as outlined above.

The project team will lodge the resource consent for Section 4 early next year and will provide the public with an update closer to the time.

We expect to complete both Sections 2 and 4 (Orakei Basin to Tamaki Drive) in parallel. Once completed this will provide a continuous fully separated walking and cycling connection.
