**Dear Marcus** 

Official Information Act request relating to subject lines of Official Information Act requests refused under sections 6(a), 6(b) and 6(e) of the Act

Thank you for your Official Information Act 1982 (the Act) request received on 3 November 2019. You requested:

"...a list of the subject lines/topics from all Freedom of Information Act requests, ranged from October 1st, 2018 until present day, which were refused under Official Information Act Sections s6(a), s6(b) and s6(e)..."

Below is a table of the subject lines given in responses made to Official Information Act requests, received by the Department of the Prime Minister and Cabinet, between 1 October 2018 and 3 November 2019, where at least some of the information in scope was withheld under any of sections 6(a), 6(b) or 6(e). I note the subject lines of these requests reflects a summarisation of the request as a whole and does not necessarily reflect all the requested information. In addition, it may not reflect whether the information summarised in the subject line existed.
