Request for Information

Police reference IR-01-19-32006

Thank you for your online submission dated 24 November 2019 requesting information on an incident that occurred at Pukeahu Park. You requested:

1. Please supply all information you have regarding an incident at Pukeahu Park in Central Wellington on Friday night - 22 Nov 2019.... Please supply all official information relating to this event - including audio transcripts and any correspondence between agencies.
2. Please provide your response time in minutes for all 111 calls you received relating to incidents in central Wellington on Fri 22 Nov 2019 from 6pm - 10pm. For this request, the definition of "response time" would be the time from when you received the 111 call to the time when a staff member was actually physically in attendance at an incident. Please also include the time the 111 call was initially received.

Your request has been considered in accordance with the Official Information Act 1982 and I enclose the following information:

- The Police event chronology for P039912307.
- Response times for Wellington Central during the specified time period.

We are unable to provide some of the information you have requested for the following reasons:


- Audio transcriptions are not provided as Police do not create these as a matter of course. Per s18(g) of the Official Information Act 1982 Police are not required to create this information to answer requests.
- Although not specifically requested by you, consideration was given to releasing audio recordings in lieu of the transcripts. As per s9(2)(a) of the act, this is also not being released to protect the privacy of natural persons.

Police considers the interest requiring protection by withholding the information is not outweighed by any public interest in release of the information.

Event Chronology: P039912307

The incident described at Pukeahu Park refers to Police event number P039912307.

Individual names and phone numbers are redacted to protect the privacy of natural persons. Although you appear to have been one of the callers, this request is being treated as an Official Information Act request since you have requested information that is beyond your own information. Police applied a public interest test as per section 9 of the act to assess whether the public interest to release the information outweighs the need to protect individuals' privacy and redaction was assessed as an appropriate balance.

If you wish to obtain a copy of the recording of the phone call that you made to Police, you may do so under the Privacy Act 1993 with appropriate identification.

Wellington Central Response Times

The table below outlines the response time for all calls for service requiring at least a timely response in Wellington Central that were entered during the time period specified. As Police systems are unable to isolate events that were entered in response to a 111 call, some of these events may have been received via non-emergency channels as well.

Note that Police were likely still dealing with events entered at an earlier time during this period. Frontline response units also cover a greater area than just Wellington Central station area.
