Information being released

There has been a call for nominations for three positions on the board of ACC that are still under consideration by the Minister (the terms of Dame Paula Rebstock, Kristy McDonald and the vacancy created by the retirement of Leona Murphy). These were advertised publicly from 14 June to 30 June 2019.

Two more terms are expiring in late 2020. They will be considered by the Minister closer to that time. It is not known at this stage whether a call for nominations will be required for these terms, or whether the members will be reappointed.
