I refer to your Official Information request which was transferred to the State Services Commission from the Ministry of Social Development on 9 December 2019 where you have asked:

- When was the Social Wellbeing Board created?
- Who is a member of the Social Wellbeing Board?
- Who chairs the Social Wellbeing Board? When were they appointed?
- What is the purpose of the Social Wellbeing Board?
- A copy of the agenda and papers for the most recent three meetings of the Social Wellbeing Board."

Establishment of the Board

The Social Wellbeing Board (formerly the Social Investment Board) was initially established by Cabinet on 10 April 2017.

Members of the Social Wellbeing Board

Current membership of the Board includes the chief executives of the Ministries of Health, Education, Justice, Social Development, and Housing and Urban Development, the Department of the Prime Minister and Cabinet, Te Puni Kōkiri, Oranga Tamariki and New Zealand Police.

Chair of the Board

The State Services Commissioner has acted as the Chair of the Board since its establishment.

Purpose of the Social Wellbeing Board

The purpose of the Social Wellbeing Board is to lead a collective approach across the State sector working on cross-cutting issues to improve the social wellbeing of current and future New Zealanders.

- section 9(2)(g)(i) the free and frank expression of opinions by or between or to Ministers of the Crown or members of an organisation or officers and employees of a department or organisation in the course of their duty.

We are finalising the consultation required with all the relevant agencies, before these documents can be released to you on 11 February 2020.
