Dear Mr McCabe

I refer to your Official Information Act request of 9 January 2020 for information relating to the number of tickets issued to Auckland Council. Your request has been transferred to New Zealand Police to provide you with a response.

You requested:

- Please provide information on the Number of Tickets Issued to Auckland Council (and all CCO organisations including Auckland Transport, Auckland Tourism, Events, and Economic Development Ltd, Panuku Development Auckland, Regional Facilities Auckland, and Watercare Services Ltd) Owned and/or Operated Vehicles by Red Light and Speed Cameras in the Auckland Area.*

Please find the information requested in Tables One and Two. Provided are the applicable offences in Waitemata, Auckland City and Counties/Manukau Police Districts issued to identities matching the list of organisations requested.

Please note that data does not include instances where a transfer of liability to a private individual has occurred, or cases in which a notice was issued to driver license's belonging to private individuals, even when such individuals were operating vehicles on behalf of the organisations listed. Additionally, selection of the organisations requested is a manual process and in some cases more than one "version" exists (e.g. Watercare Services Limited, Water Care Services Limited and Water Care Services Ltd). All versions of all organisations requested that could be found have been collated and are provided.


