## Dear Niamh Peren

Thank you for your email of 7 January 2020 to my office requesting information under the Official Information Act 1982 (the Act).

On 16 January 2020, you agreed with my office to refine the scope of your request to include:

... all correspondence between you, your office including all political and departmental officials, and the Ministry for the Environment, regarding labelling in relation to recycling, and Thumbs Up New Zealand in 2019.

I also seek all correspondence between you and your Green Party Colleagues on these subjects.

Correspondence includes: Cabinet Papers, WhatsApp messages, Texts/ iMessages, Facebook Messenger, Emails, Transcripts of Phone Calls, Transcripts of Conversations, Letters, Briefings, Advisories, Aide Memoirs, Sound Recordings, Meeting Notes.

The scope of the first part of your request was interpreted as all available correspondence between me, my office and Ministry for the Environment officials, regarding labelling in relation to recycling, and Thumbs up New Zealand, between 1 January 2019 and 31 December 2019.

The Ministry for the Environment has identified 33 documents in scope of your request. There are 4 of documents which have been withheld under s9(2)(f)(iv) of the Act, as these documents relate to matters under active consideration. 29 documents have been partially released or released in full. We have included documents in which labelling (in relation to recycling) was mentioned in passing, including email attachments, as this falls under the scope of 'all correspondence'. Accordingly, much information within these documents has been redacted as out of scope of your request, or withheld under the following sections of the Act:

9(2)(a) to protect the privacy of natural persons

9(2)(f)(iv) to maintain the constitutional conventions for the time being which protect the confidentiality of advice tendered by Ministers of the Crown and officials

6(a), 6(b)(i) and 9(2)(g)(i) to preserve international relations and international negotiating position, and officials' advice on these matters.

Under section 9(1) of the Act, I am satisfied that, in the circumstances, the withholding of this information is not outweighed by other considerations that render it desirable to make the information available in the public interest.

The table attached to this letter outlines the material in scope of your request and the decisions that have been made in withholding certain information or documents in full. Correspondence between the Minister's office and the Ministry pertaining to "Thumbs Up" includes administration relating to your communications. Regarding "labelling in relation to recycling", correspondence mostly includes ministerial letters to the public and some passing references in briefings and emails (and their attachments).

In regard to the second part of your request, political discussions with Green Party colleagues are not official information subject to the Act, so I have no information to release here.

As you are aware, following the release of the Prime Minister's Chief Science Advisor's *Rethinking Plastics* report in December 2019, I have instructed Ministry officials to investigate options for improved product labelling that indicates recyclability. This work is in its early stages, and a number of matters are still under active consideration. I expect that you will be interested in this, and I understand the Ministry has invited you to discuss the opportunities and challenges of this work, given your significant work on Thumbs Up New Zealand.

You have the right to seek an investigation and review by the Office of the Ombudsman of my decision to withhold information relating to this request, in accordance with section 28(3) of the Act. The relevant details can be found on their website at: www.ombudsman.parliament.nz.
