
- 1. Both the industry and council stakeholder groups were broadly supportive of:








Would it involve new legislation?

33. No, the powers to declare priority products and implement regulated product stewardship schemes such as a refund scheme are within the WMA. These powers include the deposit and refund mechanism, take-back services, labelling requirements, and the ability to mandate participation within a scheme if 'priority product' has been declared for these containers. Disposal bans, material or product bans, product management fees, quality standards and information reporting requirements may also be implemented to support a future scheme.



Thank you for your correspondence on 17 June 2019 on recycling in New Zealand. It's great to see you are engaged with these issues.

I share your concerns around plastic waste and the need to avoid and reduce waste and increase recycling. Niamh Perren's petition on introducing mandatory recyclability labels to my attention is a great initiative. There are a few points the petition does not cover, including how products made of partially recycled materials would be categorised under the proposed labelling system. As regions have different recycling programmes and facilities it is also important to consider that the recyclability of materials varies by region, and something recyclable in Auckland or Wellington may not be recyclable elsewhere.

Australia is developing a series of labels which show what parts of a product can be recycled, composted or can only be landfilled. I have asked the Ministry for the Environment (MfE) to consider how such a labelling scheme could be implemented here. Brand owners and the packaging industry have a responsibility to help develop a labelling scheme.

This Government is working to address the wider issues of plastic waste and recycling in New Zealand through initiatives including:

#### The New Zealand Plastics Declaration

This Declaration commits its signatories to use 100% reusable, recyclable or compostable packaging by 2025. The New Zealand-based businesses that have signed the Declaration include Foodstuffs, Countdown, New Zealand Post and Coca-Cola Amatil.

#### The Waste Minimisation Fund (WMF)

The WMF has funded a number of projects that recycle plastics locally for reuse. These include the Flight Plastics PET processing facility in Lower Hutt that reprocesses plastic drink bottles into other plastic containers. Astron Plastics also reprocesses plastics into new products using equipment funded by the WMF.

#### Our plan to recharge recycling

I was pleased to announce this Government's acceptance of the National Resource Recovery Taskforce's recommendations to improve recycling in New Zealand. Many of these recommendations target plastic waste, recycling, and pollution. Recommendations which will now be part of the MfE's work programme include:

- Undertaking feasibility studies around how to increase New Zealand's plastic reprocessing capacity
- Assessing the options for a shift away from low-value plastics that are difficult to recycle. This includes ensuring plastic packaging is able to be recycled or requiring a portion of recycled content in packaging
- Running an education campaign to help New Zealanders 'recycle right' and reduce the amount of recyclable materials going to landfill
- \$40 million has also been allocated from the Provincial Growth Fund for wasterelated initiatives. More information is on MfE's website at www.mfe.govt.nz/newsevents/major-pgf-investment-help-address-nz%E2%80%99s-plastics-challenges.

Thank you again for your correspondence. I hope you can see that this Government is committed to improving New Zealand's poor waste record. Your engagement on these issues is welcomed.

#### Background information on labelling for recyclable materials

- 1. New Zealand currently <u>does not</u> have a mandatory labelling system for identifying whether materials are recyclable.
- 2. The current approach to categorisation and labelling of plastics in New Zealand is reliant on voluntary implementation by industry. The current system used by many New Zealand producers is the resin identification system (grades 1-7). However this system identifies the type of plastic material contained in that product, not whether it can be recycled.
- 3. The current system can cause confusion for the public about how best to dispose of plastic products. In particular, compostable plastics are an area that is very complex and causes confusion amongst the public. Compostable plastics almost always require a commercial compost facility to process them properly and if confused with regular plastics can contaminate recycled material streams.

#### Australian Recycling Label

- 4. In 2018 Australia launched a labelling scheme through the co-regulated Australian Packaging Covenant Organisation. The Australian Recycling Label is an evidence-based standardised system that provides easy to understand instructions for each part of a product's packaging.
- 5. The label includes the packaging component the label is referring to (eg. lid, wrap), symbols to identify whether the component is recyclable, conditionally recyclable (recyclable in some regions only) or not recyclable.
- 6. The label has been picked up by more than 200 organisations in Australia, including some major brands and retailers. Some of these organisations also have products and brands in New Zealand. Examples of brands that have picked up the label include Nestle, Blackmores, Officeworks, Unilever, Coles and Woolworths.
- The label is underpinned by the Packaging Recyclability Evaluation Portal (PREP), which is an analysis tool allowing businesses to assess the recyclability of their product through Australia's kerbside recycling system.
- 8. New Zealand-based packaging organisations have worked with the developers of the PREP tool to localise the labels for New Zealand. However, there has been many changes to kerbside systems in response to the instability of international markets and changes to recycling accessibility need to be reflected in the PREP tool and resulting recycling labels placed on products.
- 9. The labelling scheme could be introduced to New Zealand and is already being used by some brand owners in their Australian operations. However, improvements are also needed to New Zealand's national resource recovery system in order to be able to better support recycling.

#### Talking points:

- 10. While we don't currently have a mandatory labelling system in New Zealand, a voluntary one has been introduced in Australian in the past year and we are following progress on that, and their work on packaging generally.
- 11. The Government is committed to improving New Zealand's resource recovery and recycling sector
- 12. Improving labels on products may make it easier for consumers to know what can and cannot be recycled.
- 13. In May 2019, the Associate Minister for the Environment announced a plan to improve New Zealand's national resource recovery infrastructure and system. The plan involves review of kerbside and commercial recycling, to reduce contamination of recyclables so more materials

- can be recovered, and feasibility studies for onshore processing of plastics and other materials. It also includes investigative work for plastic packaging. For example, looking at options for shifting away from hard-to-recycle plastics and investigation into regulatory options used elsewhere, for example mandatory minimum recycled content for packaging.
- 14. Part of the NRR work programme will also include education for consumers on how to recycle right such as making sure the items are clean and have non-recyclable components removed.
- 15. Plastic packaging was one of six products that we recently consulted on for regulated product stewardship. Regulated product stewardship makes producers responsible for specified problematic products at the end of their life and ensures the costs of proper waste management are shared across producers, retailers and consumers rather than just communities and the environment.
