Dear Mr Dickie

We refer to your email of 10 January 2020 wherein you sought data about vacant land held by Kainga Ora – Homes and Communities pursuant to the Official Information Act 1982 (the Act):

Can you please provide location information on your current vacant and un-developed land holdings as at end December 2019 throughout New Zealand together with the land area (sqm or hectraes) and the price paid for each vacant land parcel along with the acquisition dates?

I have considered your request under the Act and can advise that the information requested is provided in the attached table.

Please note that units 1 and 2 do not have a land area attributed to them, this because unit 1 is half a share of 0.0934 hectares and unit 2 is under strata freehold ownership. Strata freehold titleholders own a defined part of a building, such as an apartment, and share common areas such as lifts, lobbies or driveways with other owners. As such, we do not hold land area information for these titles.

Units 22, 45 and 46 were purchased with a number of other lots and therefore cannot have individual costs attributed to them.

I hope you find this information helpful.
