Sorry you couldn't join us yesterday Chris, but great that you could attend Matt, and it is fabulous to hear you have made real progress this quarter.

Here's the draft wording for the quarterly report – please could you confirm.

1. Fire and Emergency New Zealand understands the importance of the **suburbs** dataset and is working with LINZ to establish options regarding the dataset by December 2019.
  - Q1 Fire and Emergency New Zealand have the senior management approval to release suburbs under Creative Commons licensing, noting the data was already distributed to over 200 organisations.
  - Q2 Confirm which Creative Commons license to adopt with the intention of releasing suburbs data in early 2020.

Also you asked a really good question about the specification of the LINZ basemaps Matt. Could you please tell me again your specific request and I'll be happy to follow up with the team.
