Dear Mr Watkins

I refer to your request under the Official Information Act 1982 (OIA), dated 9 February 2020 and refined on the 19 February 2020, for the following information:

Can you please supply me with all of the information you have relating to the 2019/2020 restructuring of RNZ Concert and/or the establishment of a youth radio station by RNZ. This could include diary entries, briefings, advice, memos, correspondence etc. Please exclude public correspondence dated after the 4 February 2020 (as I'm guessing your office will have been flooded after the media stories began).

As communicated to you on the 28 April 2020, a decision was made regarding information in scope of your request in accordance with the OIA. The outstanding material has now been administratively processed. Please find this material enclosed.

Please note, some information has been withheld under the following sections of the OIA:

- section 9(2)(a) to protect the privacy of natural persons
- section 9(2)(f)(iv) to maintain the current constitutional conventions protecting the confidentiality of advice tendered by Ministers and officials
- section 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions
- section 18(d) the information is already publicly available.

Furthermore, the 'attached notes' referred to on page 10 of the released information have been withheld in full under section 9(2)(f)(iv) of the OIA.

I understand you have made a similar request for information to the office of Hon Kris Faafoi. Any communications between this office and Minister Faafoi's office which are in scope of your request will be considered by Minister Faafoi's office. 


