REQUEST FOR INFORMATION: OUR REFERENCE OIA 01-20-7415

Thank you for your e-mail dated 11 March 2020 requesting a copy of the Legislative Reference Tables (LRT) as used by the Police Prosecution Service, and particularly the tables for offences within the Summary Offences and Crimes Acts.

Your request has been considered in line with the Official Information Act 1982 (OIA), and I am now in a position to provide the following response.

First, it is important to provide the context that the LRT's purpose is to aggregate information from statute in a structured way, to enable Police to assemble key information for charging purposes in one place. Generally, this information is available and accessible to the public already, in a more digestible format from sources such as the Parliamentary Counsel Office webpage: <http://www.legislation.govt.nz>.

That said, please find attached a list of the current offences in LRT covering the Crimes Act 1961 and the Summary Offences Act 1981.

I trust the information provided addresses your areas of interest, but you have the right under the OIA to ask the Ombudsman to review my handling of your request if you are not satisfied with Police's response.
