Dear Gavin

I am responding to your Official Information Act (the Act) request on 7 November in relation to a parody image asking for "internal and external communication regarding the actions taken by Cameron Moore and others within NZ Police on this." You were particularly interested in "any information relating to who was aware of the threat of prosecution being made and whether it is within Cameron Moore's role to perform such actions."

Please find attached copies of the internal and external correspondence relevant to your request. Please note that personal names and some contact information have been withheld from the documents under section 9(2)(a) of the Act, to protect the privacy of natural persons.

By way of background, Police held concerns in relation to the parody image that was posted online as it was considered extremely insensitive to victims of sexual violence and offensive to the police officers who work to help them.

The real life case behind the original image (used in a Police recruitment campaign) involved a police officer who rescued a young woman from an ex-partner who sent hundreds of abusive and seriously threatening text messages to the woman over a matter of days.

Following internal legal advice as to how to approach the situation, correspondence was sent via email to the editor of the blog which had posted the image.

As the legal advice is privileged, I'm not able to provide it in this response and that information is withheld under section 9(2)(h) of the Act.

I hope this information answers your request. If you are not satisfied with this response you have the right to contact the Office of the Ombudsmen in order to request a review.






