Can LGWM please provide a copy of the attendance, agendas and meeting minutes/notes for all meetings that LGWM has had where KiwiRail was invited to attend for the past two years?

Can LGWM please provide a copy of any reports, submissions or information request responses received from KiwiRail for the past two years?

Please find attached six documents that are within the scope of your request for correspondence. Some information is withheld as detailed in the document schedule. Your requests for the attendance, agendas and meeting minutes/notes for all meetings that LGWM has had where KiwiRail was invited to attend for the past two years and for reports, submissions or information request responses received from KiwiRail for the past two years are refused under section 18(e) of the Act as the documents requested do not exist or, despite reasonable efforts to locate it, cannot be found.
