Response to official information request for expenses and fuel card use for the Mayor and CEO

I refer to your request for official information received 2 July 2020 relating to the Mayor's and CEO's fuel card use and expenses.

The information you requested is enclosed. The questions you specified have been included in bold below with our response following.
