This letter concerns your Official Information Act request, received 7 July 2020, for the following:

"Please provide me with all communications held by your office to and from Mr Andy Wigmore and/or Mr Arron Banks and/or their associates. Please also provide me with any communications to and from Darroch Ball MP and/or his office since 1 January 2020."

Please find attached all official correspondence between my ministerial office, Arron Banks, and his associates. No such correspondence has been found with Andy Wigmore and/or his associates, therefore that part of your request is declined under section 18(e) of the Act: the information quested does not exist.

In regards to the correspondence with Arron Banks and his associates, consular assistance was provided to Mr Banks that is consistent with my ministerial office's actions throughout this Government, where we offer assistance to those who encounter difficulties with emigration, and subsequently contact our office.

I have interpreted the latter part of your request as relating to the first part. No official correspondence regarding Andy Wigmore, Arron Banks, or their associates has taken place between Darroch Ball and my ministerial office in the period you have specified. Therefore, that part of your request is declined under section 18(e) of the Act.

Please note that information has only been considered that was undertaken as Minister of the Crown in an official capacity, as per section 2(1)(a)(ii) of the Act. Any other information held, i.e. in my capacity as New Zealand First Leader, has not been considered for release.

Some personal contact details have been withheld under section 9(2)(a) of the Act: to protect the privacy of natural persons.

You have the right under section 28(3) of the Act to seek a review of this response by the Ombudsman.
