Blair and I had a meeting yesterday with Bryce Edwards, at the request of the VC (Grant's original email down below).

Bryce outlined what he is doing with his expertise, summarised below:

- Commentary and media engagement is his passion and his brand for doing this (with a colleague in Palmerston North) is 'Critical Politics'
- He currently provides a regular column to The Herald, which is also sent to a mailing list of subscribers
- He also sends a daily email 'New Zealand Politics Daily' to a list of subscribers (and contributes that to Newsroom)
- He talks on media programmes and at conferences etc, sometimes for a fee
- He is an associate of IGPS (not paid)
- He does contract teaching in politics for FHSS
- He knows he needs to do fundraising for his business
- He is connected to the University but says that connection is 'thin' and he would like it to be stronger.

He wants to build his offering and find ways to monetise it.

He is looking to use for ideas/backing.

Blair saw an opportunity (I am not clear on whether Bryce saw the same opportunity or perhaps it was more that it was a new direction for Bryce that he hadn't considered before) to secure and organise the data Bryce has collected over the last 8 years and find a way to charge people for this information/insights. Blair popped into my meeting with Grant and suggested they put a person from the project office on this and find a way to gather and secure Bryce's data and give him a place to work at the University (not attached to any particular School necessarily). Blair also talked about potentially accessing research grants for this aspect.

He also talked about the opportunity he sees with election year next year, and Grant is quite excited about this. 



Payment

In terms of payment we will pay for the initial template to be created and we will pay for ongoing hosting. In the future there may be costs for the Democracy Project if:

- unique additional features e.g. poll, payment gateway
- regular maintenance to ensure it is compatible with the main browsers in use
- training additional people although this may be something you are able to do yourselves.

URL

I suggest that you register your own URL so that the project owns this. There are lots of registrars and they are all great to use. If you already have other domains you own I suggest that you keep them all with the same registrar. If you don't then I can recommend <u>1stDomains</u> as one that is easy to use. Please register your address as soon as possible as they have a way of disappearing. If you have international ambitions in addition to .co.nz you may want to register .com if it is available. 

Introducing The Democracy Project

In association with Victoria University of Wellington, The Democracy Project aims to enhance New Zealand democracy for the 2020 general election. Its role is to promote critical thinking, analysis, debate, and engagement on New Zealand politics and society. We are resolutely non-partisan and "for the public good".

The project is based at Victoria University of Wellington, but is independently run by Dr Bryce Edwards, with help from a number of other independent researchers.

Our University-based website is currently being built as a one-stop-shop for election year, and will publish a wealth of useful information, expert commentary and analysis. You can find it here: https://www.wgtn.ac.nz/democracy-project

Why the Democracy Project is needed

Democracy and progress depend on the availability of good information and analysis about politics and society. It needs a vibrant public sphere, in which debate and ideas are freely available.

In many ways, New Zealand's public sphere is relatively weak and fragmented. There are many reasons for this, but part of the problem are challenges facing the media, such as adequately resourcing the proper provision of in-depth and diverse information and analysis on politics.

Compounding the issues that weaken the scrutiny of politics, are New Zealand's weak regulation and oversight of vested interests in politics. No lobbyist regulation, revolving doors for public servants working in the private sector, regularised non-compliance with OIA requests and weak investigation and enforcement of political financing laws tilt the political field dramatically in favour of those with money and power.

There are, of course, scattered elements of a strong public sphere, with powerful and important information and analysis available in various places. This project helps to aggregate, foster, and amplify those components via a number of different projects.

Overall, the Democracy Project is an experiment in new ways of doing politics, involving academic, civil society, and media collaboration.

Who is involved in The Democracy Project?

The Democracy Project is directed by Bryce Edwards and draws on the work of other researchers. We are keen to involve other public intellectuals in the project –

journalists, academics, activists, who can contribute information and analysis. We want to promote The Democracy Project as a platform of diverse views and thought.

Victoria University of Wellington are hosting the project via a "media partnership" agreement, in which they provide affiliation and resources (such as technology and office space).

We are seeking other foundation supporters, who can make a financial contribution on the basis of supporting democracy in New Zealand. This will include individuals, businesses, and NGOs.

- More in-depth analysis drawing on expertise from experts (parliamentarians, political journalists, academics, activists, etc)

3) Democracy research and advocacy

- The Democracy Project website will be a repository of research and analysis about the quality and health of democracy in New Zealand. Issues of participation and representation require further scholarly research and public debate.
- Various individual issues will be examined that relate to health of New Zealand democracy – such as civics education, OIA reform; transparency in government; vested interests in New Zealand politics; political finance regulation.
- Issues of political power and influence are at the heart of understanding New Zealand politics and government, and this project would seek to bring together a scholarly examination of ways of understanding how power works in this country
- Individual reports will be produced on elements of democratic reform
- Ultimately, books might be published on related issues such as "Democracy in New Zealand (exploring the health of the political process and institutions) and "Who runs New Zealand?" (exploring the configurations of influence in all the major institutions of the country, from agriculture through to education).

Funding and resources – For the Public Good

The Democracy Project is focused on providing services "for the public good", to enhance the political process and public engagement in the 2020 election year, but we do not yet have the resourcing to make it all possible.

The project is primarily funded by philanthropy. We receive some resources and funding from Victoria University of Wellington, and remuneration from media companies – but these are only minimum levels, leaving us to fundraise to pay our costs.

We are currently looking for sponsors to make the Democracy Project work. There are a number of pathways for others to be involved in making the Project work. Most importantly, we are looking for "foundation partners" who will provide financial resources for the project as a whole. We are also looking for sponsors who can help finance individual elements of the project, such as the "NZ Politics Daily" email service or the new video podcasts.

Description of Services

The Contractor and the VUW have agreed to enter into a contract for the provision of media services. The term of the contract is one year from 1 December 2019 to 1 December 2020.

While the Contractor is an independent media commentator providing independent commentary and analysis on major political and social issues, the parties have agreed, during the term of this contract, to support each other in relation to 'lead thinking' on major issues affecting society.

VUW may suggest topics of discussion to the Contractor from time to time but it is acknowledged and agreed that editorial decisions will be made solely by the Contractor and VUW will not attempt to influence editorial decisions. Where appropriate, the Contractor will seek analysis and comment from academic staff at the VUW with the relevant expertise and knowledge.

The Contractor will make written and visual commentary available to VUW for use in their university channels. The Contractor and VUW agree to work together to ensure that VUW's website has appropriate places to host the Contractor's work, particularly election-related commentary and analysis.

The Contractor will describe himself as a 'political analyst in residence' at Victoria University of Wellington when association with VUW is to be made publicly. If affiliation to a particular group or unit within VUW is required, that affiliation will be with the University's Engagement Group.

Victoria University of Wellington Resources Available

The Contractor will be provided with office space at VUW's Pipitea campus.

The Contractor will be able to access the VUW's IT systems and other support systems, such as Image Services, for assistance with photography, video and voice recording.

The Contractor's primary VUW's relationship will be with the Communications, Marketing and Engagement Group.

Section 3: Terms and Conditions

AGREEMENT

DEFINITIONS AND INTERPRETATION

1.1 Definitions

In this Contract the following definitions apply:

Business Day means a day other than Saturday or Sunday or public holiday in Wellington or day on which VUW is closed (as identified in the applicable Victoria University calendar);

Commencement Date means the commencement date set out in Section 2:

Contract means this contract for services, including Section 1 (Parties and Signing), Section 2 (Contract details and Services description) and Section 3 (Terms and Conditions);

Charges means the charges payable by VUW in accordance with clause 4 as determined in accordance with Section 2:

Confidential Information means all and any material and information in respect of this Contract, the Services, the business and operations of VUW, and of every kind provided to the Contractor at any time by or on behalf of VUW, whether oral, in writing or in any other form whether or not such information is described as confidential (and includes all notes, analyses, compilations, studies, reports, valuations and other documents which contain, are developed from or otherwise reflect such material or information).

Good Industry Practice means the exercise of that degree of skill, diligence and prudence that would reasonably be expected from a provider of services in New Zealand that are substantially similar to the Services:

GST means goods and services tax within the meaning of the Goods and Services Tax Act 1985;

Intellectual Property Rights means any and all intellectual and industrial property rights throughout the world, whether subsisting now or in the future, including, without limitation, all rights conferred under statute, by common law and in equity in, and in relation to, inventions, patents, designs, trade marks, trade names, logos, getup, circuit layouts, formulae, confidential information and copyright (including, without limitation, future copyright), and any application or right to apply for registration of any of those rights;

Law means:

- any statute, regulation, by-law, ordinance or subordinate legislation in force from time to time to which a party is subject:
- (b) the common law and the law of equity as applicable to the parties from time to time;
- (c) any binding court order, judgment or decree;

Recipient means the party receiving Confidential Information under this Contract;

Services means the services to be provided by the Contractor to VUW under this Contract as described in Section 2 and any other services provided by the Contractor as agreed by the Parties; and

Term means the term set out in Section 2 or as otherwise agreed in writing.

1.2 Interpretation

In this Contract, unless the context otherwise requires:

- a reference to a clause or a section is a reference to a clause or section of this Contract; and
- (b) a reference to a party to this Contract includes reference to its respective successors in title and permitted assigns (and where the context so permits) its respective employees, contractors, subcontractors, agents and representatives.

2 APPOINTMENT AND TERM

- 2.1 VUW appoints the Contractor, and the Contractor agrees, to provide the Services during the Term in accordance with this Contract.
- 2.2 This Contract commences on the Commencement Date and will continue for the Term unless terminated earlier in accordance with its terms.

3 SERVICES

- 3.1 The Contractor will provide the Services:
 - in accordance with Good Industry Practice and the terms of this Contract;
 - (b) in an efficient, professional and cost-effective manner; and
 - (c) in accordance with any instructions or directions given by VUW.
- 3.2 In performing the Services the Contractor is to:
 - use all reasonable endeavours to avoid damaging or adversely affecting VUW's reputation, systems or infrastructure;
 - (b) comply with all Laws and all relevant VUW statutes, policies and procedures (which are publicly available on VUW's website <u>www.victoria.ac.nz</u>) including the Staff Conduct Policy and the Health and Safety Policy; and
- (c) not cause VUW to be in breach of any Law or any VUW statute, policy or procedure.

4 CHARGES AND PAYMENT

4.1 In consideration of the Contractor performing the Services and providing the Deliverables under this Contract, VUW will pay to the Contractor the Charges for the Services (plus GST, if any) in accordance with this clause 4 and Section 2.





- 4.2 The Contractor must provide VUW with valid tax invoices for all Charges on the dates or at the times specified in Section 2. A valid tax invoice must:
 - (a) clearly show all GST due;
 - (b) be clearly marked 'tax invoice';
 - (c) contain the Contractor's name, address and GST number, if the Contractor is registered for GST;
 - (d) be addressed to VUW and be marked for the attention of the person stated in Section 2;
 - (e) state the date the invoice was issued;
 - (f) name this Contract and provide a description of the Services provided,
- 4.3 Except for any GST payable by VUW all taxes, levies and duties payable in connection with this Contract under any Law are to be paid by the Contractor and not passed onto VUW.

5 WARRANTIES

- 5.1 The Contractor represents warrants and undertakes to VUW, on a continuous basis throughout the Term, that:
 - carrying out the Services will not cause the Contractor to breach any obligation it may have to any third party or any other legal obligation;
 - it has full power, capacity and authority to execute, deliver, and perform its obligations under this Contract; and
 - (c) it has, and will continue to have, all necessary regulatory and ethical approvals, releases, waivers and consents required to enable the Contractor to lawfully and ethically complete the Services.

6 INTELLECTUAL PROPERTY

- 6.1 All pre-existing Intellectual Property Rights of a party or any of its licensors (and any modifications thereto) that are not developed, commissioned or created under or in connection with this Contract, but are used for the purposes of this Contract, will remain owned by that party or the relevant licensor.
- 6.2 Legal and beneficial ownership of any Intellectual Property Rights that are developed, commissioned or created by the Contractor under or in connection with the Services or this Contract will vest exclusively in VUW.

7 LIABILITY AND INSURANCE

7.1 The Contractor will fully indemnify VUW, its officers, students, employees, contractors and agents from and against any and all liability, losses, damages, costs and expenses of any nature whatsoever awarded against, incurred or suffered by VUW arising out of or resulting from any unlawful, negligent or wilful act or omission by the Contractor;

8 CONFIDENTIALITY

- 8.1 The Recipient will maintain as secret and confidential, at all times, all Confidential Information. The Recipient agrees to:
 - use the Confidential Information solely for the purposes of this Contract; and
 - (b) disclose or provide the Confidential Information only to those of the Recipient's employees, agents, and permitted sub-contractors to whom, and to the extent to which, such

disclosure or provision is reasonably necessary for the purposes of this Contract.

9 DISPUTE RESOLUTION

- 9.1 If any dispute or difference arises between the parties in relation to, or arising out of, this Contract, both parties will endeavour in good faith to settle the dispute by agreement. Unless VUW notifies the Contractor otherwise, the Contractor will continue providing the Services in accordance with this Contract, notwithstanding the dispute.
- 9.2 If the dispute or difference is not settled by agreement within 10 Business Days under clause 9.1 then, unless agreed otherwise, it shall be referred to a qualified mediator to be agreed by the parties:
 - (a) the mediator shall determine the procedure and timetable for the mediation; and
 - (b) the cost of the mediation shall be shared equally between the parties (unless the mediator suggests otherwise).

10 TERMINATION

- 10.1 Either party may terminate this Contract at any time by giving the other party notice in writing where:
 - the other party commits a material breach of this Contract which is incapable of being remedied;
 - (b) the other party commits a material breach of this Contract that is capable of being remedied but which is not remedied within five (5) Business Days of that party receiving written notice of the breach from the non-breaching party;
 - (c) the other party becomes, or threatens to become, or is at serious and substantial risk of becoming, subject to any form of insolvency event including, without limitation, any resolution, procedure or proceedings relating to its liquidation, inability to pay its debts as they fall due, insolvency or appointment of a receiver, receiver and manager, administrator, liquidator, provisional liquidator, statutory manager or similar officer, or if it makes an assignment for the benefit of its creditors.
- 10.2 VUW may terminate this Contract at any time by giving the Contractor two week's written notice.
- 10.3 Upon termination or expiry of this Contract for any reason whatsoever:
 - (a) the Contractor will stop performing the Services;
 - VUW will pay the Contractor all Charges outstanding to the Contractor as at the date of termination or expiry; and
 - (c) The Contractor will refund to VUW on a pro rata basis any charges that apply to the period after the date of termination /expiry
 - the Contractor will return all VUW property that VUW has provided to the Contractor under or in connection with this Contract.
 - (e) each party will, upon receipt of a written request from the other party, return or destroy (at the other party's option), all Confidential Information of the other party in its possession or under its control, except that each party may retain one copy to comply with any legal, accounting, taxation or ethical requirements. Upon the return or destruction (as the case may be) of all such Confidential





Information, the party to whom the written request is addressed will provide to the other party a certificate stating that the Confidential Information returned or destroyed comprises all the Confidential Information in its possession or under its control.

- 10.4 Except as is otherwise provided in this Contract, termination or expiry of this Contract will not affect:
 - any rights and remedies available to a party under this Contract which have accrued up to and including the date of termination or expiry; and
 - the provisions of this Contract which expressly, or by their nature, survive termination or expiry.

11 NOTICES

- 11.1 Any notice, consent, information, application or request that must or may be given or made to a party under this Contract is only given or made if it is in writing and sent to the addressee at the physical address or email address of the party. The initial physical address, email address and relevant person or office holder of the parties are set out in Section 2.
- 11.2 A communication will be deemed to be received:
 - in the case of a communication sent by post, on the second Business Day after posting;
 - (b) in the case of an email, on the Business Day on which it is transmitted or, if transmitted after 5.00 p.m. (in the place of receipt) on the next Business Day after the date of transmission; and
 - (c) in the case of personal delivery, when delivered.

12 MISCELLANEOUS

- 12.1 Nothing expressed or implied in this Contract will be deemed to constitute either party as the partner or joint venturer of the other party, or the Contractor as an employee of Victoria.
- 12.2 No party will have the power to incur any obligation on behalf of or incur any liability on the part of the other party.
- 12.3 If there is an inconsistency between Sections 2 and 3 of this Contract, the terms of Section 2 prevail.
- 12.4 This Contract constitutes the entire agreement of the parties with respect to its subject matter and supersedes all previous agreements, arrangements, understandings or representations relating to that subject matter.
- 12.5 This Contract may only be amended by agreement in writing signed by the authorised representatives of both parties.
