Dear John Luke

Thank you for your email of 17 July 2020 to the Ministry of Business, Innovation and Employment requesting, under the Official Information Act 1982 (the Act), the following information:

I am requesting under the official information act information about all the positions in the Immigration New Zealand where the position holder is paid more than \$150,000 per annum.

My request covers both permanent employees and any contractors or consultants.

Please provide a list of all the positions that meet the criteria (\$150,000 or more), listed by business group in the Immigration New Zealand, and for each please provide the full position title, and the associated remuneration and an indication of whether the position is filled by a permanent employee or a contractor/consultant or other. I am comfortable if you wish to provide the remuneration information in salary bands or ranges or similar, provided they are not too large. I note that SSC uses ranges of \$10,000 when identifying chief executive remuneration which would be an acceptable range for my request.

For context can you please also provide me with the total number of staff in each business group.

If it would make complying with this request easier, I am happy to accept slightly older information, E.g. it does not need to be accurate as at the date of this request, provided it is dated within the last 12 months, and you identify the applicable date.

MBIE has interpreted your request for business group information as for information relating to the branches within Immigration New Zealand (INZ).

Please find enclosed in Annex One the INZ positions where the position holder can earn more \$150,000 per annum as a base salary. This information is accurate as at 19 August 2020. The table shows the relevant INZ branch for each position and the minimum step and maximum steps within the associated salary band.

MBIE is refusing to supply you with the specific remuneration figures paid to individual employees under section 9(2)(a) of the Act, to protect the privacy of natural persons. Specific remuneration figures can be negotiated by staff on an individual basis on appointment. Individual staff are also identifiable in the positions listed. MBIE are therefore releasing the information to you as the remuneration associated with the salary band. I do not consider that the withholding of this information under section 9(2) is outweighed by public interest considerations in making the information available.

Please note that position bands 20F and above are based on fixed remuneration and include the employer superannuation contribution. Under the current pay restraint guidance, there are no rate increases this financial year for staff in positions within these bands and while the maximum ranges are 120% of the midpoint, MBIE is currently not appointing above 105 per cent of the maximum rate.

The table below shows the total number of INZ employees who currently earn more than \$150,000 per annum as a base salary, with the total number of fixed term/permanent MBIE staff members and those engaged as contractors. Where only the hourly rates are held for contractors, the figure has been converted to an annualised figure. This means that the annualised remuneration rate would not necessarily reflect the actual total 12-month earnings for the role. This data is accurate as at 22 July 2020 and does not include any remuneration increases for those in W or X step ranges where applicable as part of the FY 19/20 remuneration review.

Please note that MBIE's response does not include data on contractors who are employed to assist with short term projects only or roles where the salary costs are shared with other agencies. Contractors who are employed offshore are also not included.
