## Dear John Luke

Thank you for your further email of 28 July asking for the following information under the Official Information Act 1982 (the 'Act'):

I noted on your reply to me earlier [DIA1920 0759] there are 17 successful applicants, may I have the name of each successful applicants and what positions they have been appointed to. Also may I have an updated number if there are any changes, as the range of my last request was 1 march 2018 to 31 may 2020.

Further, your previous reply confirmed you have made total of 388 recommendations, may I ask what position you had made the recommendations to."

I will answer your questions in turn:

1) The names of the 17 successful applicants and their positions.

The Office of Ethnic Communities' Nominations Service database does not record the specific position within a State sector board or committee that a candidate is appointed to. This aspect of your request is therefore declined under section 18(e) as the information requested does not exist.

We can provide the names of successful candidates and the State sector board or committee that candidates were appointed to. The individuals that were appointed following a nomination from the Nominations Service database is attached as **Appendix A**.

2) An updated number if there are any changes, as the range of my last request was 1 March 2018 to 31 May 2020.

OEC is aware of one additional appointment bringing the total to 18 as at 28 July 2020. This appointment is included in Appendix A, being Sumati Govind appointed to the New Zealand Lottery Grants Board.

3) What positions the 388 recommendations were made to.

As stated above, the Nominations Service database does not record the position a candidate is recommended for and therefore this aspect of your request is declined under section 18(e) as the information requested does not exist.

We can provide as **Appendix B** the State sector boards or committees that recommendations were made to, and the number of recommendations.

The figure of 388 recommendations quoted in our previous response was calculated by adding the monthly totals of individuals recommended within every month over the period 1 March 2017 to 31 May 2020. This figure has been recalculated to a total of 418 recommendations. The recalculated total includes where an individual was recommended to more than one position within a month.

Please note that as parts of your request has been declined under section 18(e) you have the right, under section 28(1)(a) of the Act, to seek an investigation and review of our decision by the office of the Ombudsman.
