

I wanted to check in before filming starts tomorrow.

While we understand the project is changing each day as more information comes to light, I wanted to raise that we are now in the space of redoing pieces of work.

With the filming tomorrow, we are very aware that key messages will change so we have to be clear about the deliverables and the outputs.

Originally we had three videos,

Message to staff from Bill to go into his newsletter

2. Why video with Stevie and Bill

3. Job lots message from Stevie and Bill

Extra videos that have been requested

1. Video of 9(2) from Rotary with Bill (if he turns up)

2. Message from Bill to librarians.

We have a very tight timeframe to edit and add graphics etc. As of 5pm have not had script signoff of the key messages. We understand that is will happen tomorrow at 12pm.

Anna took Bill through the script earlier in the week and he was satisfied with the work done at that point. It was my understanding that we would go through the script tomorrow with Bill before we film but realise that this will not allow for many changes. Bill has back to back meetings tomorrow so if you would like him to view the script at an earlier stage it's best to send it through tonight or early tomorrow morning if possible.

In the unlikely event of these not happening at 12pm tomorrow - we will halt filming until we signoff. Understood.

Signoff of the video edits - National Library will have two rounds of edits - any additional edits will be charged extra at \$150 per hour. Understood.





Her comments below and some talking points for today's meeting:

- How do we reconcile these competing messages "growing a nation of readers" with "rehoming 600,000 books"
- We need to keep in mind we are growing a nation of readers yes, this is true but we can't build this into a campaign. The Community of Readers programme is at a strategic point where they can shout their work from the rooftops.
- She shouldn't present this as an opportunity to take books of value as opposed to the fact that these are old and worn and unused
- Books going online messaging as a lead message "services to schools" are trying to put printed books into the hands of children because they have particular value in regards to getting kids to read. Research shows that print books have way more impact than online. There is an enormous growth in books online but reading hard copies of books is much more preferable to reading online – research shows this.
- This collection is mostly non-fiction and a lot of these can be found online but the thing we need to keep away from is any implication that because you can get published content on the internet that could replace the need for print in terms of supporting reading for enjoyment. Refer to latest research in PISA results.

Storage angle is preferable – storage is not infinite, we are always looking to grow and strengthen our NZ and Pacific collecting and specialist areas which includes children's literature. We need to get rid of our low value books so that we can do this and the OPC are low value.

- Services to Schools have been updating the Minister on the growing a nation of readers and the Prime Minister has a special interest in this area.

- The OPC was a collection of targeted interest books that were sent to NZ because there was a gap not being met by the NZ public libraries. – this isn't the case – NL ordered these books. For years this was ongoing acquisition – this message needs to be more accurate.
- Is there a greater risk to not front footing this?
- Services to Schools nation of readers is one of the three priorities for the next ten years. • The project that's started is the community of readers – the Minister and Prime Minister needs to see results by June 2020. National Reading Summit is likely to take place before June 2020. National Library will be running this high-profile, cross agency summit.
- We need to understand this context and the tension between the two projects. •
- Given both this article and the latest PISA results about declining enjoyment of reading • Elizabeth is thinking the Library really should have some sort of response to the media this week. Services to Schools want to front foot a response this week around the positive work the National Library is doing to help our growing nation of readers.

There have already been developments from yesterday afternoon so yes, two meetings/calls a week is a good idea. It seems we are dealing with a moving feast. I think the one thing we can be sure of is the PR exercise before Christmas. I thought I would be on my own for this but be good to have your support.

We have \$6,500 - \$8,000 for media placement so this will be either a pure social media campaign OR choosing one media outlet to spend our budget with and relying on media for the rest of the coverage. There's also the road of partnering with an organisation or business so that we can tap into their channels. We have an existing relationship with AirNZ so can tee up a meeting with Kathryn (sponsorship person) to explore further.

Bill is keen to pursue his contact with Rotary and is trying to set up a meeting with them this week. It is his hope we can run our campaign with them and they'll take the lot. Best case scenario Rotary partner with the National Library and take a large amount of the OPC for their book fairs. We run our campaign along these lines and use Rotary book fairs as the door where the public can access this quirky collection. The funds raised from these book fairs would at least in part go to fund literacy initiatives to help grow our nation of readers.

Scope change:

- We need to be really upfront and clear.
- Any ideas that pop up need a cost alongside the more detail the better.
- We need to make sure that if there are requests coming from our end that start to creep outside the budget we need to know before proceeding.
- tikewise, if you wish to propose anything that sits outside the budget we need a cost alongside and time to consider.

The last agency I worked with didn't do any of these things and there were additional costs that accrued without us being notified. This being central government every \$\$ needs to be accounted for. To the best of my knowledge \$20,000 is the allocated budget. If you come up with an amazing concept that costs \$25,000 then you're welcome to put that on the table but there are no guarantees so there needs to be awareness of a scale up scale down approach.

We have an amazing procurement person within the team so I'll check in with him to see if he can help check any contracts. There will be paperwork from our end so I'll get him to start on that today or tomorrow at the latest.


