Amy Adams (DOB 19 May 1971) was educated at Rangitoto College in Auckland and moved to Canterbury in 1988.

Amy attended Canterbury University where she studied law, graduating with first class honours in 1992, leading to becoming a partner with Mortlock McCormack Law in Christchurch, specialising in commercial and property law.

Amy became a Member of Parliament at the 2008 General Election representing the large rural electorate of Selwyn in the Canterbury province. During the 2008-2011 Parliamentary term Amy was given the roles of Chairperson of the Electoral Legislation Select Committee and Chairperson of the Finance & Expenditure Select Committee as well as being a member of the Regulations Review Select Committee and the Justice and Electoral Select Committee (in 2011). She was also a member of the National Party's Environment, Agriculture, Local Government, Defence and Economic caucus committees.

In Amy's first term she founded the New Zealand Parliamentary Defence Force Scheme and undertook placements with the Royal New Zealand Navy and Royal New Zealand Air Force.

Following the 2011 General Election Amy was promoted to Cabinet becoming Minister of Internal Affairs, Minister for Communications and Information Technology and Associate Minister for Canterbury Earthquake Recovery. In March 2012 Amy was named Minister for the Environment and relinquished the Internal Affairs portfolio.

Amy is a previous member of the NZ Law Society's Women's Consultative Group and the Institute of Directors and was the chairperson of the Board of Trustees of her local school for the four years prior to entering Parliament.

Amy lives in Aylesbury, with her husband Don and their two children, on their 600 acre sheep and crop farm. Prior to her entry into Parliament she was a keen sportswoman with particular interests in tennis and triathlons.

Major General Arthur David Gawn was born in Marton, New Zealand in May 1958 and was educated at Dunstan High School.

He enlisted into the New Zealand Army in August 1978 and was posted to 2/1 RNZIR. He undertook initial officer training at the Officer Cadet School, Portsea in Australia and graduated into the Royal New Zealand Infantry Regiment as a Second Lieutenant in June 1980.

After a period of post graduate training and Platoon Commander experience at the Waiouru Training Depot, Major General Gawn was posted to the 2nd/1st Battalion, RNZIR, Burnham Camp as a Platoon Commander in Alpha Company. In December 1981, he was posted to the 1st Battalion, RNZIR, Singapore as a Platoon Commander in Charlie Company and then as the Reconnaissance Platoon Commander.

In May 1984, Major General Gawn returned to New Zealand, posted as the Staff Officer Air and Special Duties on Headquarters Army Training Group, Waiouru. In December 1985 he was posted to Headquarters Land Force Command, Takapuna as the Staff Officer Grade Three Co-ordination. He was promoted to Captain in January 1987. In October 1987, Major General Gawn was posted to the 1st Ranger Company as the Officer Commanding. Due to Government cut-backs this unit was never fully manned and it was disestablished in late 1989.

Major General Gawn was posted to Headquarters Land Force Command as the Staff Officer Grade Three Peacekeeping in December 1989. In December 1990, he was posted as the New Zealand Instructor at the Australian Defence Force Academy, Canberra. Major General Gawn returned to New Zealand in December 1992 to the 1st Battalion RNZIR at Linton Camp as a Company Commander. In September 1994 he was posted to NZFOR UNPROFOR as the Officer Commanding Kiwi Company based at Santici Camp, Bosnia.

Major General Gawn returned to New Zealand in March 1995 and shortly thereafter was posted to the United States to attend Staff College at Leavenworth. On completion of Staff College in June 1996 Major General Gawn was selected to attend the School of Advanced Warfighting at Quantico. He returned to New Zealand in June 1997 and assumed the appointment as Instructor, Tactical School, Waiouru. In January 1998 on promotion to Lieutenant Colonel he was posted to Development Branch, Army General Staff Wellington as the Staff Officer Grade Doctrine and Capability Development. He moved to Trentham in May 1999 when the Capability, Analysis and Doctrine (CAD) Cell was set up.

In July 2000 Major General Gawn was posted to the New Zealand United Nations Transitional Authority as the Commanding Officer, the 3rd New Zealand Battalion Group. He returned to New Zealand in May 2001 and assumed the appointment of Joint Staff Officer Grade One Doctrine and Evaluation (J8), Headquarters Joint Forces New Zealand, Trentham. While

posted to the Headquarters Major General Gawn was promoted to Colonel and assumed the appointment of J3 Operations.

In December 2002 Major General Gawn assumed the appointment as Assistant Chief of Staff, Development Branch Army General Staff Wellington. In January 2005 he commenced study at the Australian College of Defence and Strategic Studies. After completion of this course in December 2005 he assumed the appointment of Commander 3rd Land Force Group, Burnham Military Camp. On 18 October 2007 he was promoted to Brigadier and became the Land Component Commander within Headquarters Joint Forces New Zealand. With effect 6 December 2010, Major General Gawn assumed the position of Deputy Chief of Army. With effect 1 May 2011 Major General Gawn was promoted to his current rank and assumed his current position of Commander Joint Forces New Zealand.

Major General Gawn was awarded a Member of the Most Excellent Order of the British Empire (MBE) in the 1996 New Year's Honours List. In May 2001, Major General Gawn received a Force Commander's Commendation for his role in East Timor.

Major General Gawn is married to Anna and they have twin sons, Hamish and McKenzie, and a daughter, Briar.

Author & High Country Farmer



Christine has been a teacher, business woman and educator - co-founding, with Alan Duff, the hugely successful 'Books in Homes' programme and then the Gifted Kids Programme. She has served 10 years on the Northern Advisory Board for the Salvation Army, the last 3 as Chairperson. Additionally, Christine served as a board member on the AUT Foundation for 6 years.

Following the death of her husband John Fernyhough in 2002, she purchased the historic and breathtakingly beautiful Castle Hill Station, near Forters Fass in Canterbury.

Castle Hill is a difficult farm to run - rainfall 1100 mm, altitude from 700 - 1300 m with a short growing season from late October until early December. Castle Hill is a ten thousand acre high country farm running 7,000 su - Merino sheep, Angus and Hereford cows and Red deer. Christine and her husband John have a finishing block at Sheffield. This farm - Glen rowan - runs Perendale sheep, finishes some stock from Castle Hill and operates as a dairy grazing unit.

Christine speaks up for the high country community: the misconceptions held by those who live in the city about farming and farmers, the fact that changes to the Correspondence School system make it difficult for isolated rural families to educate their children these days, land tenure review, the loss of production off and the issues of pest and weed control within the Department of Conservation's vast estate, the question of public access, how to manage Merino with the loss of the 'tops' and the debates around irrigation and conversion to dairying debates.

In 2007 Christine wrote with Louise Callan *The Road to Castle Hill: A High Country Love Story.* This title was Bookseller's Choice for 2008 and has sold over 30,000 copies. In 2009 she wrote *Ben and Mark, Boys of the High Country* - aiming to bring a greater understanding for city kids of life in the country.

In 1999 Christine was awarded a Queen's Honour, Officer of the New Zealand Order of Merit (ONZM) for services to education and the community. Christine was further honoured for her services to the community in 2010 being awarded a Queens Honour, the Companion of the New Zealand Order of Merit. She is also a Paul Harris Fellow — sapphire.

Damien is past president of the Buller Promotion Association, a member of the West Coast Tourism Development Group, a member of the West Coast Business Development Board and a founding director of Buller Community Development Company. He also won West Coast Young Farmer of the Year.

As well as having a close involvement with CTL's entrepreneurial and growth agenda, Guy is a Trustee of Cookie Time Charitable Trust, www.ctct.org.nz, established in 2003 to help Kiwi kids discover their gifts. The Trust serves the wider community through positive actions, projects and initiatives in three main areas: innovation in learning, thinking differently and physical pursuits.

Each year, more than 70 university students throughout the country are recruited to run their own Christmas Cookies businesses. 

He worked for the National Bank of New Zealand in Dunedin and Wellington until 1987 when he embarked on a rugby sojourn to Scotland and England, playing for Dunfermline 1987/88 and Broughton Park in Manchester 1988/89. He returned to Dunedin where he studied Commerce and Accounting at Otago University, which he graduated from in 1993. He worked at Taylor Mclachlan Accountants in Dunedin, Dunedin Hospital and ACC. Recently in 2005 he earned a masters in Health at the University of New South Wales in Australia. Prior to his political career, Woodhouse was the CEO of Mercy Hospital in Dunedin from 2001 to 2008.

An avid rugby follower, Woodhouse played age group rugby for Otago and South Island rep teams and premier rugby for Dunedin and Western Suburbs in Wellington. He also refereed 84 premier and approximately 20 representative colts and 'B' provincial matches.^[1]

Woodhouse reduced the majority from 7,155 in 2008^[2] to 3,489.^[3] National also lost the party vote by 420 votes.

A member of the Health and Transport & Industrial Relations Select Committees in the 49th Parliament, Woodhouse was elected as the National Party's senior whip on 20 December 2011.^[4] He is the head of the Parliamentarians for Arthritis group and is active in the Parliamentary Sports Trust as a rugby player and referee.

In a reshuffle in January 2013, Woodhouse was made a minister outside cabinet and was given the Immigration, Veteran's Affairs and associate transport portfolios.

Sir Owen Glenn KNZM, ONZM Philanthropist

From humble beginnings, Glenn Family Foundation's founder Sir Owen Glenn's entrepreneurial spirit and business acumen have made him an internationally-recognized leader in the logistics industry as well as an inspiration to others. He was the founder, owner and executive chairman of OTS Logistics Group until it was sold in January 2012. Sir Owen's freight forwarding operation utilised state of the art eCommerce solutions that allowed his clients to track where in the world their goods are. He grew this business from nothing into a billion dollar revenue company with offices in 105 countries that is now one of the world's largest logistics companies.

He received an Officer of the New Zealand Order of Merit in the 2008 as recognition of his business achievements and his work as a philanthropist and in 2010 the Paul Harris Fellowship Rotary Award. In 2011 he was also awarded CPA Australia's highest honour - Honorary Fellow of CPA (FCPA), in recognition of his global entrepreneurial success.

Although spending a lot of his time overseas, Sir Owen still regards himself as a New Zealander. In addition to his other international philanthropic work through the Glenn Family Foundation, in 2005, Sir Owen contributed NZ\$7.5 million to The University of Auckland Business School. This was a landmark philanthropic contribution in New Zealand education, believed to be the largest private donation in New Zealand educational history, in recognition of which the University named the iconic building in which the School is housed, the *Owen G Glenn Building*. Shortly after this, Sir Owen donated an additional NZ\$500,000 to establish the Barry Spicer and Owen G Glenn PhD Scholarships

Philanthropy remains Mr Glenn's passion and most recently in July 2012 Sir Owen gave \$8 million for a pilot programme in Otara focused on eliminating child abuse and family violence. In September 2012 he launched an independent Inquiry into child abuse and family violence in New Zealand with a further \$80 million has been tagged in his Foundation to address this issue.

Many people are unaware that his foundation has supported hundreds of humanitarian causes throughout the world including Sir Owen's birth country, India. The Foundation's philosophy very much mirrors Sir Owen's personal outlook on life focusing on the importance of education, health, helping oneself and family as the foundation of a community.

Sir Owen's endless philanthropic endeavours saw New Zealand's highest award bestowed on him, named a Knight Companion New Zealand Order of Merit, in the 2013 New Year's Honours.

She has held multiple director nositions.

formerly as the National Director for Te Roopu Tomokia, a church-based Iwi-Maori land-research

project funded through the World Council of Churches Programme to Combate Racism, and the Christian Conference of Asia. She re-entered the NZPubic Service through the Department of Maori

Affairs as the Regional Solicitor in 1981 and with the Harkness Award spent two years in the United

States of America, from 1983-1985 at Harvard University as a Graduate Student, then selected by the United Nations Graduate Intern Programme appointed to the UN Security Council Division in New York. This was followed by a brief term at the Brookings Institute Government Studies Programme based in Washington DC and Executive Oval Office fellowship to the Reagon Administration at the White House. She returned in 1985 to New Zealand and the Department of Maori Affairs, but was nominated in 1989 to Oxford University. Upon a second return to New Zealand she renewed her

interest in the Maori Women's Welfare League, Arahina Branch and became the Regional President of this voluntary organisation for Tamaki Makaurau. She remains a life member of this organisation.

She has extensive community, corporate and public sector involvment, spanning over 30 years.

In late 1989 she was asked by Ngati Whatua whaea, Ani Pihema, to accept a nomination onto the Auckland Institute of Technology Council, the largest Polytechnic in New Zealand. Through this involvments he became the first Maori Women to Chair the Council, and by the early 1990's, in partnership with Dr John Hinchcliffe Ceo, had lodged the application for the first University of Technology. This involvment was to be a major engagement for her, spanning over 24 years of involvment.

In 2000 she was selected for an inaugural Manawahine Award, from the Maori Women's Welfare League, and received this Award from Te Arikinui, Dame Te Atairangikaahu, the Patron of this voluntary organisation. As a young student, she had been a recipient of the Tumate Mahuta Scholarship from the Tainui Trust Board, and this recognition was well received by her entire whanau.

In June 2004, she was elected to the New Zealand Institute of Management, Auckland Division, and is the first Maori to be appointed to this body. She was awarded an NZIM Fellow Award in July

2004, having been a member of the NZIM since 1996.

She has received recognition from Her Majesty the Queen, with a Suffrage Honour for services to women in 1994, and in 1999 received the Companion of the New Zealand Order of Merit for services to New Zealand.

In 2009 she was honoured to be a member of the IX Government Delegation to the Indigenous Forum at United Nations Headquarters in New York, and was accorded Speaking Rights to the \$,500 delegates to the Forum. This was all the more remarkable as New Zealand had not yet signed the Draft Declaration on the Rights of Indigenous Peoples, while the Australian, United States and Canada, and New Zealand Governments had expressed reservations about the wider implications of signing this United Nations backed initiative. The speech focused on the achievements of our nation as an original signatory of the United Nations Charter, and of the record of this country in relation to the Crown Settlement of past Treaty of Wilating injustices, Crown A pologies to Iwi Claimant Groups, the recognition of Te Reo, the Maori Language has an offical language gof this country, alongside English and Sign language and the innovative moves to advance Maori Language the Stephenson and Company of the Company of

In 2011 she was nominated to the role of Patron for the Limited Service Volunteer Programme, based at the Hobsonville base in West Auckland and since that time she has maintained an active role to encourage as many Rangatahi as possible onto this programme, and through to job seeker opportunities. In August 2011, she was appointed by the NZ Cabinet to the Territorial Forces Employer Support Council, through to September 2013. On 15th April 2014, she has been re-appointed for a second term to the Council, through to 16th April 2016.

In December 2012 Pauline Kumeroa Kingi CNZM was nominated by the Auckland University of Technology Council for an Honorary Doctorate from the University, for outstanding and sustained contribution to Māori Advancement and Education and multiple governance roles within the university. 28 of her whanau and friends celebrated the occasion on the 9" May 2013 at the Sir Paul Reeves Building at the Auckland University of Technology, Wellesley Campus in Central Auckland.

I was involved in scouting till form 3 or 4. Bluff had a very strong Sea Scout troop where an excellent grounding and love of small boats was developed. Other outdoors interests of tramping and rugby were also pursued.

Following scouts I joined the local yacht club which was also very strong at this time. I borrowed \$300 from my brother and bought an international moth. In the first season I received the RSUP trophy and the nickname "Patches" on account of the time spent with the bottom of the boat pointing up and all the rework required following my bumps with things much harder than the hull. At the end of high school I moved to Christchurch to complete a Bachelor of Engineering degree. Continued with Rugby, tramping and sailing. Owned a 2 man javelin yacht with a friend.

Following university I spent a year working at Kaiapoi then moved to Auckland 1985. Married in Christchurch in 1985.

Lived and worked in the Auckland area 1985 to 1990. 4 jobs in 5 years - not great on the resume, however, it was good for gaining experience.

First son born, Auckland 1988, Second son born Calgary, 1991, Third son born Auckland, 1999.

In 1990 we moved to Canada with 1 son and 1 on the way. Through one of my old work colleagues we were introduced to a great range of people in Calgary who we still maintain contact with today. Three of these people had a major influence in our future in establishing a business in NZ.

Returned to NZ in 1993. Arrived home close to broke. My wife went back to full time work and I looked after the children and made a start on a new business as a contractor. Our children have all left home now and are making their way in different forms of endeavour. My first wife and I continue to live rurally in Patumahoe where we enjoy home grown veggies, eggs, beef and honey.

He was born in Christchurch, New Zealand and raised in the Waikato. He attended high school in Christchurch and in 1967 began his career as a computer programmer, at age 18.

Career

In 1969 he wrote the initial direct debit and direct credit applications which are in common use throughout the New Zealand banking industry today, and by age 22 he was Head of Computer Programming at the Comalco aluminium smelter in Bluff, which at that time was the largest industrial project ever undertaken in New Zealand.

He returned to Christchurch around 1972, making it his home permanently. He lived in Jeddah, Saudi Arabia, working as a programmer for Caterpillar Inc. between 1976 and 1978, after which he returned to New Zealand to develop a new concept in computer programming through his creation of the fourth generation language known as LINC. LINC remains New Zealand's most successful software export to date. He has resided in Christchurch for the past 30 years, where there is now a street named after him, Sir Gil Simpson Drive [1]

Sir Gil is the founder of the **Aoraki Corporation**, developers of the LINC 4GL and Jade programming language, and **Jade Software Corporation** [2] (http://www.jadeworld.com), who are also well known for their past sponsorship of Christchurch's Jade Stadium. His latest venture is **Jolly Good Software Pty Ltd**, which he founded in 2006 and manages from the Jolly Good gallery in Christchurch [3] (http://www.jollygood.co.nz).

Sir Gil is recognised around the world as an advisor and speaker on Information Technology, particularly in the area of e-commerce.

Honours and awards

In the New Year Honours 2000 Simpson was appointed a Knight Companion of The New Zealand Order of Merit for services to information technology, commerce and the community'. [1] Later in 2000 Simpson was made an honorary fellow of the New Zealand Computer Society's Supreme Award for the most outstanding contribution to computing in New Zealand in the 20th century. [2] In 2005 he was inaugurated into the New Zealand Business Hall of Fame [4]



Six Tim Wallis is a Coaster. He grew up in Greymouth where he went to Greymain Trimary School before going to boarding school in Christchurch. On leaving school (at the end of 1956) he spent three months at Burnham as part of the compulsory military training scheme, where as Private 826168 he became a gunner in the Royal NZ Artillery Corps. After finishing his time there he spent one term at Canterbury University before deciding that becoming a doctor wasn't for him. He went back to the West Coast where he went to work in the timber business, learning it from the forest floor up. Later he and his brother George, who built up a trucking business, combined forces to market and transport timber all over Otago. During this time Tim spent as much free time as he could deer stalking high in the mountains around Wanaka and the West Coast, often with his great friend Robert Wilson. Tim became convinced that if they could shoot deer in sufficient numbers Robert's family firm could export the meat to Europe. They tested this idea by cutting up a few carcasses on Robert's mother's kitchen table in Wanaka and sending the cuts off to a buyer in Germany. At first he used an old jet boat to bring loads of carcasses out of the valleys and then hired a light plane. However he very

quickly realised that the most effective way to go would be to use helicopters. He hired a Bell 47 DI model from Nelson and a Canadian ex-airforce pilot to fly it but very quickly realised that he would have to learn to fly a helicopter himself if the whole exercise was to be cost efficient. At this stage he began a long career of borrowing money from the bank to finance ideas which no one else thought would work. He learned to fly - first a fixed wing plane then a helicopter - and although he took himself back to flying school to gain extra hours of training in mountain flying there were several 'incidents' while both Tim and the helicopters he flew discovered what they could do together. In 1968 the worst of these accidents resulted in him breaking his back, making him a partial paraplegic. Once he had got his flying licence back the venison industry progressed and he became interested in capturing deer live so they could be farmed. He pioneered methods of doing this from the helicopter, worked out ways to farm them and held the first live deer auction in the world on his farm in Wanaka. Several times during these years bankruptcy threatened and it seemed the whole project would need to be abandoned but eventually deer farming became a major part of New Zealand's agricultural industry.

With the financial success of the deer venture Tim was able to start investing in another big interest — WW2 fighter planes. He bought an old Mustang in America and had it restored. This was followed by other fighters from America and England, most notably the Spitfire. He began Warbirds Over Wanaka, the big airshow which has been held every second Easter since 1988. In 1994 he was knighted for his contribution to aviation, agriculture and the community. In 1996 while taking off in his Mark 14 Spitfire he had an accident which knocked him unconscious for nearly three months. He has made an amazing recovery but still suffers the consequences of that injury. These days he oversees the management by his four sons of the company he started and makes movies.

Lady True Wallis grew up in Dunedin. After university she joined the local television station DNTV2 where she became interested in all aspects of film production. During five years overseas she worked in the film industry, mainly in New York and London. In 1974 she and Tim were married in South Africa (during a trip undertaken to study methods for the live capture of wild animals!) and have lived in Wanaka ever since. They have four sons — Toby, Jonathan, Matthew & Nick — all of whom are pilots. Toby and Nick run their own helicopter business, Jonathan runs the family farm, Minaret Station, and is general manager of the family business (the Alpine Group) and Matt has started a hunting and tourism company.

Prue has a passion for photography, an interest in art related activities and is a member of the NZ National Parks & Conservation Foundation.

Stuart Smith bio

Stuart is the Member of Parliament for the Kaikoura electorate, successfully contesting the seat in the 2014 general election.

In Parliament Stuart is Deputy-Chair of the Primary Production Select Committee, and a member of the Social Services Select Committee. He is also a member of several caucus committees including the Agricultural Caucus Committee, the Regional Development Caucus Committee, the Education Caucus Committee, the Bluegreens (National's advisory group on environmental issues) and the Rural Broadband Initiative working group.

Having grown up on a Mid-Canterbury sheep farm, Stuart has been involved in primary industry his whole life. He was a sheep and deer farmer before relocating to Marlborough and moving into grape-growing, later setting up his own wine-making business.

His main priorities as MP are regional economic development, the development of water storage and irrigation projects and the expansion of ultra-fast and rural broadband.

Tane NORTON, of Ngai Tahu, was born on the 30th March 1942 in Waikari, Canterbury where he grew up and attended school at Methven District High School.

Growing up, Mr Norton played local rugby for Methven and Mid Canterbury, showing much talent in the game. In 1969 he was selected to play for the Maori All Blacks as hooker and eventually lead both the All Blacks and the Maori All Blacks during the 1970s to many victories. He played a total of 197 first class games with 61 games for The All Blacks. Tane's greatest success was captaining the All Blacks to victory against the 1977 Lions.

When Mr Norton retired from first class rugby, he was then the oldest man to be captain of the All Blacks at the age of 35. Since retiring Mr Norton has stayed actively involved in rugby. Coaching in Christchurch and then taking the role as Vice President of the NZ Rugby Union between 2001 – 2003 and President 2003 -2005. Mr Norton is also a Board Member of the Charitable Trust for Critical Rugby Injuries and a member of the Earthquake Trust Advisory Board, as well as this, he was made a Member of the New Zealand Order of Merit (MNZM).

Mr Norton currently has a huge involvement in local communities and is involved in the 'Living Legends' project to plant 175,000 native trees around New Zealand. He has a passion for youth and assists where he can in organisations focused with youth development. Mr Norton is on the board of the Canterbury Youth Development Programme Trust.



Tony Gibbs CNZM

I grew up in Titirangi and was a restless child and teenager often dreaming of far away places and on

the day I turned 15 years old left home eager to find adventure in the world. Some months later I joined a meat cargo ship in Lyttelton as Galley boy and we set sail to England (I had my 16th birthday in the Panama Cannel) and when we finally arrived in London I was paid off. From there I roamed Europe working in various countries and later I found the Middle East, Turkey, Israel and Iran. I spent time around the Blue Mosque in Istanbul where \$US1 a day was enough to feed you. With a Persian man we ran a car from Istanbul into Iran only to find we had duty to pay on arrival. I worked in various Kibbutz in Israel where I spent around 6 months, picking fruit and riding horses looking after cattle. Later I hitchhiked through Turkey and the Yugoslavia area including Bulgaria and up into Scandinavia where I worked for several months before joining a tramp ship as deck hand and galley hand steaming around the Baltic and Northern and Southern Europe. All in all I was away from New Zealand for around 7 years. In England I meet Val whom I married 6 months later, I was then 23 and she was 20 years old and we have now been married 44 years.

On returning home I worked for various companies holding different positions, however when I was in my mid twenties I formed my own sports goods company which was very successful and when I was 30 we sold the business and for the first time we had some capital. During this time I became very aware of the corporate world and started investing our limited funds in various companies and property. Later I became involved with Brierley Investments Ltd with whom I had developed a relationship and subsequently worked with them for many years managing different investments and representing them on various corporate boards. Following the 1987 Stock market crash I personally became involved with a leading research company and for a several years following was its Chairman. After that I was invited to represent Guinness Peat Group plc and later joined them on a full time basis. We became involved on many takeovers, mergers acquisitions and spinoffs with a wide range of New Zealand. American and English companies.

Wayne "Buck" Shelford MBE started his rugby in Rotorua as a youngster and made his Auckland debut in 1982. He stayed with his North Shore club and automatically moved to North Harbour when the separate union on the North Shore was formed in 1985. It was that year in which he was first chosen for New Zealand, for the abandoned tour of South Africa. He went on the replacement tour of Argentina and played in four of the matches.

Being the most dominant No 8 in the country, Buck was an automatic choice for the 1987 Rugby World Cup, and played in five of the six matches, and also played in the Sydney test in which the All Blacks regained the Bledisloe Cup. He took over from David Kirk as captain for the tour of Japan in October and November and played in each of the five matches.

He played 26 tests for the All Blacks including winning 14 successive games as Captain from 1987 – 1990, with only a drawn test against Australia in 1988 to mar the perfect record. Upon becoming captain, Buck brought his teammates to Te Aute College, a Māori school, to see the students perform a traditional haka. Although the All Blacks had been performing the haka at the start of their matches since the team's inception, it was Buck who taught them the proper way to perform the "Ka Mate," haka.

Buck and his wife Joanne have two children, Lia (born 1981) and Eruera (born 1985), and also adopted his god-son Mitchell Haapu (born 1987).



Willie Jackson

Chief Executive Manukau Urban Maori Authority

Willie Jackson is well known for his advocacy particularly in the Maori, union and broadcasting area. He is one of the leading spokesmen for urban Maori in the country and is generally recognised as one of the main spokesmen and leaders for Maori in Auckland especially in the South Auckland area. He is the chief executive of the Manukau Urban Maori Authority, the South Auckland representative on the New Zealand Maori Council, the Chairman of the National Urban Maori Authority, Chairman of the 21 station lwi National Maori Radio Network - Te Whakaruruhau and also the Chairman of the Maori Television Electoral College – Te Putahi Paoho.

Willie is also one of the country's leading media personalities, he is a broadcaster, political commentator and talkback host for Radio Waatea and Radio Live and in 2011 he and his former co-host John Tamihere were named New Zealand's top talkback hosts. He currently hosts a daily national talkback show on Radio Live with former TVNZ star Ali Mau. He has been a political commentator for a range of TVNZ shows over the last decade and featured regularly on TVNZ's election night coverage in 2005, 2008, 2011 and 2014. He was the host of the award winning Maori Current Affairs show Eye to Eye for six years on TVNZ and had his own show "Willie Jackson's News Bites" on Maori TV for three years. He has been a regular spokesman on men's issues on TVNZ's Good Morning show and he is currently employed as the political commentator for the TVNZ Marae show, a position he has held for the last three years. As well as this he has been a columnist for Fairfax Media since 2008 and has regular weekly columns that are published in the Manukau Courier.

His iwi affiliations are with Ngati Maniapoto and Ngati Porou. Willie is well connected within political circles and can discuss politics from first hand experience as a former MP. He was the leader of the Mana Motuhake Party – the first Maori party in Government, and deputy leader of the Alliance.
