Thank you for your email on 17 November 2020, requesting the following information under the Official Information Act 1982 (the OIA):

- 1) Total number of non-priority (off-shore included) resident class visa applications accepted (on-hand) to date discriminated in Skilled Migrant Category, Talent (Accredited Employer) Resident Visa and Others.
- 2) Number of ON-SHORE non-priority resident class visa applications accepted (on-hand) to date discriminated in Skilled Migrant Category, Talent (Accredited Employer) Resident Visa and Others.
- 3) Monthly list with number of non-priority (off-shore included) resident class visa applications lodged between January 2019 to date discriminated in Skilled Migrant Category, Talent (Accredited Employer) Resident Visa and Others.
- 4) Monthly list with number of ON-SHORE non-priority resident class visa applications lodged between January 2019 to date discriminated in Skilled Migrant Category, Talent (Accredited Employer) Resident Visa and Others, listed per month.
- 5) Monthly list with number of ON-SHORE resident visa class applications, discriminated in priority and non-priority, allocated to a Case officer between August 2020 to date.

Our response

Immigration New Zealand (INZ) does not have a specific Skilled Migrant Category (SMC) queue but one for skilled residence applications. The applications are not split into two separate queues based on the application category. All applications are separated into the stated priorities as per Immigration Instructions A16.1.

Please note that for questions 3 and 4 there has been numbers of applications which have been redacted under section 9(2) (a) of the Official Information Act 1982. The number of applications in these tables is under 5. To protect the information potentially being used to breach the privacy of any applicants this had not been provided.

8) A comprehensive and detailed description of the internal procedures followed by Case Officers to process Skilled Migrant Category and Talent (Accredited Employer) Resident Visas

This question was clarified on 7 December 2020 to be the step by step processes which immigration officers (IOs) follow to process SMC and RFW application.

Please find attached in appendix A the standard operating procedures for SMC.

Please find attached in appendix B & C, training material and a mock assessment (used to demonstrate to IOs a RFW assessment) has been provided for the RFW category. Further to this, I have linked the operations manual to the RFW talent accredited employer category https://www.immigration.govt.nz/opsmanual/#41990.htm

As IOs will follow this when assessing the applications. The category does not have a standard operating procedure.
