We refer to your request under the Official Information Act dated 20 November 2020 in relation to the 2020 grade distribution for 200 level Law Papers and the 2020 threshold for 200 level Law Honours. We respond to each of the parts of your information request below.

#### **2020 grade distribution for 200 level Law Papers**

You have asked for confirmed grades of all students taking 200 level Law papers (LAWS 201, 202, 203 and 204) in 2020.

Please see attached a schedule contained the grades that you have requested.

Please note that the University's standard practice is not to report on numbers where those numbers are below 5. This is for privacy reasons. Where the numbers of the candidates are very low, there is a risk that the identity of those candidates could be determined/inferred. Accordingly, we withhold this information pursuant to section 9(2)(a) of the Official Information Act.

#### **Threshold for 2020 200 level Law Honours**

You have asked for the 200 level Law 2020 grade required to be offered a position in the honours programme.

The University's Law Faculty approved the honours cut-off mark for initiation in to Honours from second year as 79.5%.

I trust that this information will be helpful.

We note your right to seek a review of these decisions via a complaint to an Ombudsman. However, we would welcome the opportunity to discuss any concerns with you first.
