## Official Information Act request for the CTAG July 2015 New Zealand Terrorism Threatscape Assessment

Thank you for your request made under the Official Information Act (the Act), received on 2 February 2021. You requested:

"Can you please provide me with a copy of the Combined Threat Assessment Group's July 2015 New Zealand's Terrorism Threatscape Assessment. This assessment has been referred to on page 456 of the Ko tō tātou kāinga tēnei: Royal Commission of Inquiry into the terrorist attack on Christchurch masjidain on 15 March 2019, released to the public on 8 December 2020."

The Combined Threat Assessment Group (CTAG) falls within the responsibilities of the New Zealand Security Intelligence Service (NZSIS). I believe the CTAG assessment you have requested is more closely connected with the functions NZSIS and, accordingly, I have decided under section 14(b)(ii) of the Act to transfer your request to the NZSIS.

The NZSIS has the usual timeframes under the Act from receipt of this transfer to make a decision on your request.
