Thank you for your Official Information Act (the Act) request received on 15 January 2021.

You have asked for:

- All information regarding the acquisition of items by [the National Library] from Louise Pomare, Maui Ormond Woodbine Pomare, Miria Louise Pomare, and Te Rakaherea Woodbine Pomare.
- Whether items were gifted or sold, and if so, what price was paid for each item
- What proof of ownership was required by the National Library of New Zealand before a purchase/gift was made/accepted.

In response to the first parts of your request, a requisition form and an acquisition check list have been attached with this response. Some information on the forms has been withheld under Section 9(2)(a) to protect the privacy of natural persons.
