Your request regarding “*whether any Police dogs, tasers, pepper spray, or any firearms were used to effect the arrest*” is answered below.

For the period 1 December 2020 through to 18 January 2021(inclusive), there were 291 TOR events where the Subject Resolution was recorded as an arrest, and the tactical options used included either Police Dog, TASER, OC Spray, or Firearms. Please note that a TOR event is the reportable use of a tactical option by one officer against one individual; as such, multiple TOR events may occur at the same incident.

This data has been drawn from Tactical Options Reports (TORs) which had completed the review process as of 11 February 2021 and is subject to change.

The figures provided are provisional and are the most accurate available at the time of analysis. Efforts have been made to clean and correct any identified data entry errors; however, inaccuracies may still exist. As such, these figures may not be consistent with future reports.

Your request for “*an anonymised ID number assigned to each officer*”, is refused pursuant to section 18(g) of the Act, as the information requested is not held.

I trust that you are satisfied with my response to your request. If not, you have the right under section 28(3) of the Act to ask the Office of the Ombudsman to seek and investigation and review of my decision.
