The Emergency Housing question could be answered with:

In Government, we gave the commitment that those who needed urgent help with housing

should get it.

We were not happy with the reality that had developed for increasing numbers of our most vulnerable New Zealanders where they had to live in cars or someone's couch, and we said anyone who needed help should come forward and they would get help.

That opened up the true extent of neglect in housing assistance that had been happening and meant that we have had to apply emergency housing help on a scale that recognises that need.

There may be lines from the Oral Question from Louise Upston on Emergency Housing that could be useful too:

## **Question No. 10—Housing (Public Housing)**

10. Hon LOUISE UPSTON (National—Taupō) to the Associate Minister of Housing (Public Housing): Is he confident that the Government's emergency housing policies are fit for purpose; if so, why?

Hon KRIS FAAFOI (Associate Minister of Housing (Public Housing)): When we came into Government, we said that those in genuine need of emergency housing should come forward and they would get support. Since then, we have built more State houses than any Government since the 1970s, funded over 2,000 Housing First places, and piloted and rolled out the Sustaining Tenancies programme. Our emergency housing policies are constantly under review to ensure that vulnerable New Zealanders' needs are being adequately met. This Government inherited a housing crisis from a predecessor who refused to admit one existed. Hon Louise Upston: Who is responsible for placing families with kids into emergency housing, when it was reported that houses in the scheme were without stoves and ovens and that houses were essentially building sites?

**Hon KRIS FAAFOI**: That is an operational issue, but the Ministry of Social Development (MSD) does most of the operational issues in terms of determining who gets an emergency housing Special Needs Grant placement.

**Hon Louise Upston**: Is he saying it's acceptable for a family with children to be placed in a house without a stove or oven?

Hon KRIS FAAFOI: No, and that's why I've asked officials to see what work can be done around the placement process to ensure that properties are adequate for the needs of the people who are being housed. I think the member might be referring to a media report where private properties were used. That system was used between January 2018 and June of this year, and was primarily used because some of the accommodation that we were supplying, like motels, was not adequate for larger families.

**Hon Louise Upston**: Does he consider the taxpayer funding of up to \$3,000 per week for uninhabitable emergency housing good value for money; and, if not, how much money has been spent on uninhabitable emergency housing?

Hon KRIS FAAFOI: We always want to make sure that people are in appropriate housing, whether it be transitional housing, emergency housing, or social housing. I am disappointed that on a small number of occasions when private market rentals were used, some of that may have been inadequate—there are reports of it being inadequate—and that's why we've asked officials to make sure we look at the placement process to ensure that the properties are appropriate for families that use them.

**Hon Louise Upston**: On how many occasions did this happen, and how much money was spent on it?

Hon KRIS FAAFOI: I don't have that figure on me. What I would tell the member is that during the period where private rentals were used in Auckland, only 13 percent of emergency housing Special Needs Grant people that were looked after were looked after in private market rentals—I think the figure is just a little short of 1,100—and, again, it's disappointing to see a small number of those where some of those properties may not have been adequate.


Hon Louise Upston: Was he aware that after the scheme was extended in 2018, it was reported that once a provider joined the emergency housing scheme through providing a motel or hotel, it could then rent out extra rooms or houses into the scheme, and that the status of those would not be checked; and, if yes, is the scheme working as intended?

Hon KRIS FAAFOI: Well, as the member would know, the scheme is no longer in place.

**Hon Louise Upston**: Can he confirm whether every emergency housing provider is inspected to ensure that emergency housing places funded by MSD meet basic living conditions; and, if not, why not?

**Hon KRIS FAAFOI**: I repeat to the member: I've asked officials to look at the placement process to ensure that all properties are adequate for the people who are placed in those properties.

Associate Housing Minister Kris Faafoi has provided the following comments:

- · I had a positive meeting with the Mayor of Masterton and other Wairarapa representatives who updated me on the supply issues in Wairarapa, and I'm thankful for their insights.
- · I am seeking advice on how we might deal with public housing demand issues in Wairarapa given there is only the Trust House community housing provider operating in the region after a former National Government decided to sell-off the region's entire state housing supply.

## Wairarapa Messages

#### The need for emergency or transitional housing in the Wairarapa

As the demand for number of application on the Housing Register continues to grow, so does the need to be able to provide people with long term public housing. This is a national trend and not limited to the Wairarapa region.

We are balancing the long-term goal of increasing public housing supply with the imperative to provide immediate support to vulnerable whanau and individuals who find themselves without a home.

We're pressing ahead with delivering more long-term transitional housing across the country to ensure we are supporting people and whānau in urgent need of housing through the ongoing funding of transitional housing services.

### **Transitional Housing**

Emerge (20 places) and Women's Refuge (3 places - safehouse) are the transitional housing providers in the Wairarapa. There are no known issues at present.

#### **Public Housing Plan Targets**

In August 2018, the Government released the Public Housing Plan 2018 – 2022 (PHP), which outlined the number and type of public housing places that the Ministry of Housing and Urban Development (HUD) is looking to secure in each location i.e. 6,400 net additional places across New Zealand over the 4 years to June 2022 or around 1,600 places per year.

Of those, 60 places were earmarked for Masterton and South Wairarapa District.

There are currently 20 new builds within the planned CHP pipeline for Masterton, which is due for completion in early 2022. (NB: – these are the Emerge places that we will hopefully contract in the next few months.)

#### Community Housing Providers operating in the Wairarapa

#### Emerge housing deal in Masterton

HUD has received a formal application for public housing from Emerge. Because the deal is still being negotiated, I can't comment further on that specific proposal. Officials are working now with Emerge to finalise the deal.

However, we know there is a need for more public and transitional housing in many regions throughout the country.

The Salvation Army (TSA)

TSA is a key CHP nationwide however only has a small presence in the Wairarapa. As at 30
August 2020, TSA had 3 active public housing tenancies in Wairarapa.

#### LinkPeople

LinkPeople specialise in supporting clients transitioning from mental health services. As at 30
August 2020, LinkPeople had 10 active public housing tenancies in the Wairarapa.

#### Trust House

- Trust House is the significant public housing provider in the Wairarapa. Kāinga Ora exited from the region in 1999, when it sold its portfolio of 541 houses to Trust House for \$10.3m (\$19k each).
- 4. As at 30 August 2020, Trust House had 193 active public housing tenancies in the Wairarapa. Emerge
- 5. As at 31 July 2020, Emerge had one active public housing tenancy in Wairarapa.

## High level housing messages

The Government is firmly focused on increasing the supply of housing throughout the country. In the past three years we have succeeded in putting together the machinery to deliver change. Under this Government, more houses are being built now than at any time since the 1970s.

### **Building more state homes**

- 1. The Government's housing reforms have empowered Kāinga Ora to accelerate the pace and scale of new home building and large development projects. In the three financial years to 30 June 2020, we built over 3,500 new state homes to help meet the growing demand for public housing.
- 2. However, with demand for public housing continuing to grow, we have more to do and Kāinga Ora has an ambitious programme to build more state housing to address this need.
- 3. Our housing pipeline continues its upward trajectory to help meet demand. At 30 June 2020 we had
- 4. 2,679 state houses under construction. And, we are once again ramping up to deliver even more state homes following the Government's Budget 2020 announcement to dramatically increase the number of state and transitional homes.
- 5. Over the next four years, Kāinga Ora plans to invest \$11.2 billion in its housing stock, resulting in a net increase of approximately 8,250 additional state homes.

#### **Public housing**

- 1. Budget 2020 recently invested \$570m to deliver 8,000 new places, approximately 6,000 public houses and 2,000 transitional housing places.
- 2. By 2024 we will have delivered more than 18,000 places and we remain committed to increasing supply further.
- 3. No one likes to see an increase in people needing public housing, however, as a result of our policies more people and whānau are being helped than ever before.

#### **Transitional Housing**

- 1. We've also increased the supply of transitional houses significantly. There are now 3,474 transitional housing places across the country, helping thousands of vulnerable New Zealanders and whānau, with more to come.
- 2. We can house over 10,000 households over a year. Even though COVID-19 shut down construction sites and slowed our progress, during July 2020 we still managed to bring on average 14 extra public and transitional housing places every day, and we remain on track to exceed our state housing delivery goals.

#### **Housing First Programme**

- 1. Across New Zealand, there has been significant investment in Housing First to address chronic homelessness.
- 2. Housing First is a proven, internationally recognised approach to housing and supporting people who are experiencing homelessness and multiple, high and complex needs.

- 3. Housing First recognises that it is much easier for people to address complex needs, such as mental health and addiction, once they are housed.
- 4. The approach is to provide housing quickly, then offer tailored support for as long as it is needed to help people stay housed and address the underlying support needs that led to their experience of homelessness.
- 5. Evidence shows that this model has been especially effective in helping people experiencing homelessness and high and complex needs stay housed and lead healthier, safer lives.
- 6. Budget 2019 a \$197m investment ensures that these existing Housing First programmes are sustainable and can continue to deliver services for more than 2,700 people and whānau over the next few years.
- 7. During July 2020 another 185 households were accepted into the Housing First programme.

#### **Progressive Home Ownership**

- 1. As house prices have increased, families who would once have bought a home have been priced out of home ownership. Families who, for example, can afford mortgage payments but are constantly chasing the market in terms of saving a deposit, or families who can get a small deposit together but are not able to afford the ongoing costs of a mortgage at current house prices.
- 2. The Government's \$400 million Progressive Home Ownership Fund will help between 1,500 and 4,000 New Zealand families buy their own homes. The Fund will enable low to median income households partner with a progressive home ownership provider to access shared ownership, rent to buy, or leasehold arrangements to step into home ownership.
- 3. The Fund has a specific aim to address housing affordability issues for three priority groups: Māori, Pacific peoples, and families with children. The Fund will focus on places in New Zealand where housing affordability issues are most severe and where progressive home ownership can best help to address this.

## VACANT CROWN PROPERTIES IN MASTERTON - CONVERSION TO PUBLIC HOUSING

I am writing about two currently vacant Crown properties in Masterton (6 Seddon Street - an expolice house - and 8 Green Lane Road RD8 – an ex-MSD house) that are in the process of disposal.

There is a pressing need for public housing in Wairarapa. The region has been growing and house prices and rents have been increasing. This shows no signs of stopping.

As you might know, the public housing stock in the Masterton, Carterton, South Wairarapa and Tararua districts was transferred from Crown ownership to the Trust House in 1999 – some 500-odd properties. While Trust House provides a small amount of them as social housing it has a narrower and more commercial focus than Kainga Ora; it also lacks the Crown's balance sheet which impacts on its ability to finance expansion. Further, the absence of a Kainga Ora presence locally means that the very welcome investments and expansions being made nationally to increase public housing stock by-pass the Wairarapa.

In my submission, the housing problems we face in Wairarapa require the return of the Crown's public housing provider, Kainga Ora. This process must start somewhere and the above two properties might usefully become first steps towards renewal of public housing in the Wairarapa.

Thank you for your email of 12 June 2020 about two properties at 6 Seddon Street and 8 Green Lane RD8, in the Wairarapa. I appreciate your interest in increasing the number of warm, dry homes in your region.

As you may be aware, through Budget 2020, the Government has committed to deliver 8,000 new public and transitional housing places so that more New Zealanders can have a place to call home that are warm, dry and safe.

The Government, in partnership with others, is continuing to deliver on its existing public and transitional housing commitments throughout 2020. The Government wants to take the time to make sure we are delivering the right homes, in the right places, at the right time. This is why we will be working with the sector to update and build on the current Public Housing Plan over the coming months.

The Ministry of Housing and Urban Development is working with the developer and Emerge Actearoa on a proposal for a public housing development in Masterton, and is working hard to reach a deal as quickly as possible.

In regards to the properties at 6 Seddon Street and 8 Green Lane RD8, Oranga Tamariki is having initial discussions with the Ministry of Housing and Urban Development regarding the future use of these sites.

Right now the Government is seeing the highest demand and need for homes in other regions. Käinga Ora – Homes and Communities is making more efficient use of its land to increase the pace and scale of housing supply throughout New Zealand to meet this demand. Käinga Ora is moving as quickly as it can to help meet that need through its development programme for both state and affordable homes.

We are writing to you to let you know that we have taken the decision to sell our s 9(2)(a) properties. All 7 remaining properties will be sold, including the property that you currently rent from us.

We are marketing the properties on the basis that all existing tenancies are to remain in place. This means that your tenancy will continue and be taken over by any new owner who will become your new landlord. While we have taken this step to provide you with certainty around your tenancy you should be aware that we cannot provide any guarantee that any new owner will continue the existing tenancy agreements on a long term basis. However, you can rest assured that under law any new owner will need to provide you with at least 42 days notice of any intent to alter your tenancy.

This is not a decision that we have taken lightly and we have spent the last 9 months canvassing and exploring options with central government agencies, local government and local social housing providers in the hope of being able to transition the properties to an appropriate social housing provider. Unfortunately none of the parties we have engaged with are willing or able to acquire and operate the properties on a basis that is acceptable to us.

As you will appreciate, WBS is not a natural owner or operator of social housing in our community. WBS is a locally owned, community based and orientated financial institution that offers loans and investments. Our focus is on providing social housing developers and providers with access to funding to enable them to boost the availability and quality of social housing in the Wairarapa region.

We do not have the resources or skill-set to provide the level of specialised service that is required to effectively operate, manage and maintain a social housing portfolio. In the absence of being able to find a suitable social housing provider to assume ownership of the properties we feel that we have no choice but to put the properties onto the open market.

The properties will be marketed by David McHattie of LJ Hooker and the marketing process will commence with immediate effect with the aim of being completed prior to Christmas. Our intent is to minimise disruption to you during this process but as you will appreciate we will need to access the property for photography and to arrange viewings. David will be in touch to make these arrangements and we would appreciate your assistance with this process.

### Hello to you all.

(I have cc some others into this email to keep them in the loop only.)

It is now 12 months since I started my quest to get the homeless of Masterton Homed. We have a day shelter that offers hot showers, washing machine facilities, a social place to meet and people who care, hot food and somewhere to charge phones.

That in its self is an amazing blessing for these street people.

Thanks to the generosity of the St Matthews Church people we have had this open for nearly 10 months. It is not a long term option. Some of you have given small donations to help us which we are very grateful for, I think many people just don't want to acknowledge this dark side of their town.!!!! St Matthews gives free rent and free power. Thank you St Matthews Church!!!!

Like all other larger towns in NZ we have people living on our streets. These people have grown up here, gone to school here and sometimes I find it hard to believe, but have family here. They do not want to move, as suggested to "other towns"

These people are only a small number at the moment numbering about 8.

There appear to be all sorts of barriers to getting these people into some sort of accommodation!!!!!

I am quite frankly OVER IT another winter fast approaching. To much red tape. What are we doing here!!!!

All these people want and need is something very simple. They don't fit into conventional accommodation, So don't go there anymore!!!

I have looked all over central town and keep coming back to the old Lansdowne School site as being the only place I know of were we could do this.

Come ON everyone. Yes we have Covid 19 so what!!!

Okay so lets look at this. They need a 24hr toilet, they need a sink to wash things, and maybe somewhere to sit under cover and some cabins to sleep in to have their own space and things. So cold running water is the only service they need. I will clean the lou and empty rubbish and clean the site daily if needed!!!

So we are able to build lovely tables with covers over them at all the DOC sites and at Henley Lake. Why can we not build one for our homeless. We have so 9(2)(a) from the Brickery with materials to build cabins. We have so 9(2)(a) from Cameron Construction and the Makoura College carpentry students able to do this. We have many other people who will DONATE materials and their time. These homeless don't need power.

Come on Masterton please can we do this!!!! We built a park for the kids why not some accommodation for our homeless.

The ramp opposite the A1 takeaways is their <u>HOME</u>. We try to take food to them everyday. Please don't evict them, please don't take their wine off them, because they are in a liquor free zone. If you can't find them another option then leave them alone!!! So call off the council and call of the police and leave them alone. You are NOT going to change anything by doing this. Give it a break.

Did you all know that T (one of our homeless) had his pack stolen with his phone and all his mega belongings in it. He has nothing. We have given him a school bag and I'm his phone contact. Did you know he gives amazing hugs.

I love this man and it breaks my heart to think that we can't give him somewhere to lay his head. He only needs a cabin. He has grown up in Masterton all his life. He has been homed privately during Covid 19 and is loving it. Do you know how hard it is to get someone!!!! to pay \$200 a week for this accommodation during this time. We are paying huge money for some homeless to be in motels during Covid-19!!!!! Oh RED Tape again!!! and I'm just a volunteer!!!!!

Dear Minister,

My name is <sup>s 9(2)(a)</sup> and I am a first year teacher at Dannevirke High School. While I would like to commit to this high school and this region. I, like many other residents, must deal with the same issue of a complete lack of affordable housing. I have tried to purchase a property, but that has fallen through due to meth contamination making it uninsurable. This was the cheapest property on the market. The next cheapest property on the market at the time of writing this is currently 7 times my net income.

I am now fighting over the only three rentals in town currently available with everyone else who is trying to remain. This is due to my current rental falling through during January due to the owner wanting to move in family members who can't find any other accommodation.

I am thoroughly disappointed in Labour's management of the housing crisis. I am thoroughly disappointed in Labour's 'support' of the regions. Your party claims to be backing 'our regions for recovery' due to Covid per the party website. Yet your policies have made them completely inaccessible for young adults during your first term. So why any further investment is needed is absurd. Three years ago, when your party came into government, the median house price in Dannevirke was \$177,000. Today it is now \$274,000. Unless your party is going to divert the \$200,000,000 fund for economic development to affordable housing, there's no point creating more jobs. No young adult can find a rental or afford to purchase a house. Those jobs will remain empty until the employers say 'we can't find locals' and import more foreign labour. Because locals won't work on a wage that leaves them unable to afford reasonable accommodation.

I would like to know how your party plans to support young professionals who want to help our regions. Because from my perspective your government seems to want to price young professionals out of the country. Young teachers already can't afford to teach in urban areas on the starting pay scale. We're now being pushed out of rural areas. Aside from overseas. Where, exactly. Does the Labour Party expect us to go? Are we meant to start our career living in campervans at a campground? In a tent? In our cars? Under a bridge? On the streets? If I had started my career under National, I could've afforded a house. Based on the property prices at the end of their government. Under Labour I'm trying to avoid becoming homeless.

I understand the failures of the Labour Party do not fall on you alone. But if you kindly inform your colleagues about how they're destroying the regions and driving young professionals out. I would be very grateful.

Please find below the approved lines on The Wairarapa.

- 1. Currently there is no Kāinga Ora Homes and Communities presence in the Wairarapa.
- 2. To support delivery of the Public Housing Plan, Kāinga Ora will need a presence in the region and this is being worked through.
- 3. In the meantime Community Housing Providers (CHPs) are helping to provide public housing in the region.
- 4. There are 160 public housing places in Masterton District, most of which are provided by Trust House.
- 5. Te Tūāpapa Kura Kāinga Ministry of Housing and Urban Development and Kāinga Ora is talking with the Mayor of Masterton and other CHPs about increasing the supply of public housing.

#### Background:

- 1. Trust House is the only significant public housing provider in the Wairarapa. HNZ exited from the region in 1999, when it sold its portfolio of 541 houses to Trust House for \$10.3m (\$19k each).
- 2. Masterton is a designated refugee resettlement location with some 110 individuals expected to be resettled there.
- 3. The following table provides data on demand and housing supports for Masterton for the quarters ending 30 June 2020 and 30 September 2020.

Public Housing Tenancies	141	160
Transitional Housing Places	23	25

4. The increase in public housing places is due to 39 "redirects," representing Trust House "Sitting Tenants" who the Ministry of Social Development has deemed eligible for the



# HEALTHY HOMES STANDARDS – RENTAL PROPERTIES – SUGGESTED ERROR IN THE HEATING STANDARD FORMULA

A constituent has raised a concern about the formula being used to satisfy the heating standard for rental properties. In simple terms, the constituent says the kilowattage said to be required to meet the obligation to warm the main room to 18 degree from the minimum temperature on the coldest day of the year is set too high. This means larger and more expensive heat pumps are being installed, heats pumps which will prove very costly to operate and so are unlikely to be turned on by budget conscious tenants. If correct, this would seem to be counter-productive in achieving the policy objective of warmer, dry homes.

This office is not in a position to objectively assess the veracity of our constituent's concerns however, I would appreciate some information as to how the formula was devised and whether there has been any feedback about the formula that suggests others may believe there is an error as suggested by our constituent. I would also appreciate being able to refer the constituent to a person within MBIE with whom the constituent can further discuss their concerns.
