Official Information Act Request

Thank you for your information request under the Official Information Act 1982 (the Act) of 4 March 2021. You requested copies of all briefings and communications received by the Minister of Justice or his office during the period 1 September 2020 to 3 March 2021, regarding miscarriages of justice or wrongful convictions, including any briefings or communications from, or relating to, the Criminal Cases Review Commission. The Minister has transferred your request to the Ministry for response.

Five documents fall within the scope of your request. Three of those documents are Ministry of Justice legal advice on individual applications for compensation for wrongful conviction and imprisonment or for the exercise of the Royal prerogative of mercy. These documents are withheld on the basis of privacy [s 9(2)(a)] and legal professional privilege [s 9(2)(h)].

Another document is the Ministry's legal advice contained in an initial briefing on compensation for wrongful conviction and imprisonment and the Royal prerogative of mercy. The final document is an aide memoire from the Ministry responding to several requests for legal advice from the Minister stemming from the content of the initial briefing. These documents are being withheld on the basis of privacy and legal professional privilege, except for the enclosed table of successful compensation claims attached to the initial briefing.

The reasons for withholding these documents are not outweighed by the public interest in their release.

Notes
