I would also like to know if the company that produces Trikafta, Vertex, has approached Pharmac to begin the process of approving Trikafta for New Zealanders with cystic fibrosis, and, if not, whether the Minister of Health has considered approaching Vertex to ask them to do so. To assist in developing a response, my aim in making this request is to ascertain the Government's current position to Trikafta to understand if there is a timeline for the drug to become funded in New Zealand.
