I've got a couple of notes about the response letter:

1. This paragraph near the near the end of page 2 – I don't think the wording is quite right. I've made a suggestion here but not sure if that is what was meant. And I'm not sure the full stop after the word example is correct?:

In addition, some of the information that was previously provided in the Office of the Director of Mental Health and Addiction Services Annual Report is now being provided in a timelier way and with a broader lens across the sector via other reports and information. For example. The Ministry of Health is committed to ensuring the transparency and accuracy of providing data relating to the Mental Health Act as it has done over a number of years. However, we are looking to improve how user-friendly the data is and where the information is provided.

Over the past two years there have been significant changes made in mental health and addiction at the Ministry of Health, including the establishment of a Mental Health and Addiction Directorate. Some of the information that was previously provided in the Office of the Director of Mental Health and Addiction Services Annual Report (Annual Report) is now being provided in a more timely way and with a broader lens across the sector via other reports and information. An example of this is the Mental Health and Wellbeing Year in Review outlining the progress made by the Ministry in the first year of delivering to He Ara Oranga: Report of the Government Inquiry into Mental Health and Addiction and the Budget 19's mental health, wellbeing and addiction initiatives, including an update on work progressing changes in relation to the Mental Health Act. There have also been some changes in how mental health data is collected, for example, the introduction of national reporting by District Health Boards (DHBs) on the use of restraint in mental health facilities was brought in from July 2020.

We are also placing a significant amount of this information online so that in future it is easier to provide more regular updates rather than only releasing information once a year. However, implementing these changes has taken longer than anticipated.

The publication of the 2018 Annual Report was delayed due to the response to the COVID-19 pandemic taking priority, and accordingly the 2019 Annual Report has also been delayed. Also, as you have noted, there is a lag time between when DHBs report their data to the Ministry, and the publication of that data. This is due to a three-month time-lag for all DHBs to submit their data to the Ministry followed by data quality processes that the Ministry undertakes to ensure that the data is reliable. However, the Ministry is committed to making the data in relation to the Mental Health Act publicly available and is expecting to release the data for 2018 and 2019 by March 2021

I've had an initial look through the documents (I got a bit of a fright when I saw over 400 pages!!)

I've made a few comments about emails that are not in scope (and were included incidentally in the collated documents). And also I noticed that there were a lot of repeated documents – eg pps 246 to 290 all seem to be repeats of earlier documents.
