On 12 April 2021, you emailed the Ministry of Social Development (the Ministry) requesting, under the Official Information Act 1982 (the Act), the following information:

- *The last 5 years of data for money given out to people as "Accommodation Supplement" categorized by each year. If possible, I would love to see the same data separate out by main cities such as Auckland, Wellington, Christchurch, Tauranga and Hamilton as well.*

On 16 April 2021, the Ministry contacted you to clarify your request to receive data by Territorial Local Authority Boundaries or Regional Council Boundaries. The Ministry also asked if there were any additional cities that you would like added into the request. Later that day, the Ministry received your refinement to the following:

- *I Would like to have the information of the council boundaries only. Please add Hastings and Napier City councils as well along with already requested "Auckland, Wellington, Christchurch, Tauranga and Hamilton".*

The Accommodation Supplement (AS) is a non-taxable benefit that provides assistance towards a client's accommodation costs. It is available for people who rent, board or own their own home and a person does not have to be receiving a benefit to qualify. It is calculated using a formula that takes into account geographical location, family size, accommodation costs, income and tenure type (renting, boarding or home ownership). - The number of Accommodation Supplements is the number of individuals, couples or families receiving an Accommodation Supplement for their housing purposes. It is not necessarily a count of households
- Regional Council is based on a client's address as at each period.
- To protect confidentiality the Ministry of Social Development uses processes to make it difficult to identify person or entity from published data. These data tables have had random rounding to base three applied to all cell counts in the table.
- The impact of applying random rounding is that columns and rows may not add exactly to the given column or row totals.
- The published count will never differ by more than two counts.
