## **Request for Information: Statutory Vacancies**

I write in reply to your email of 9 May 2021 requesting the following information:

- a list of statutory vacancies for which the nomination period has closed but the appointments remain under consideration
- a list of the positions that will be advertised in the course of the remainder of 2021.

I have considered your request in terms of the provisions of the Official Information Act 1982.

I understand your request to relate to positions that are characteristically advertised in the public domain by the Ministry of Justice (MoJ). There are, for example, tribunal appointments that are required by legislation to be filled by a District Court Judge or by members of a specific professional body. In these cases the positions are filled on the nomination of the Chief District Court Judge or the relevant professional regulatory body.
