Thank you for your email of 16 June 2021 relating to the following information you requested on 18 May 2021 from Oranga Tamariki—Ministry for Children (Oranga Tamariki) under the Official Information Act 1982 (the Act):

"Copies of the responses to OIA requests received by the Ministry and/or the Minister for Children between 2016 and 2020 containing:

- Lists of reports, aide memoires, briefings, memos etc. provided to the Minister over a specific period

Please include responses from former Ministers for Children during this period as well as the current Minister."

On 16 June 2021, we provided the information you requested. We redacted some information from the documents released as out of scope, and other information to protect the privacy of the original requestors.

On the same day, you asked us to release the information in full, noting that your request was for:

"copies of the responses" of these OIA requests, and not "copies of these responses as they relate to the Children's portfolio", and these responses included these titles, they are in fact in scope of the original request."

You indicated that you are happy for us to continue to redact information to protect the privacy of the original requestors.

The information you requested is attached in Appendix One. Requestor details have been withheld from these documents under section 9(2)(a) of the Act to protect the privacy of individuals.

## **IN-CONFIDENCE**

As per our previous response, you will also note that information was withheld in the original responses under the following sections of the Act.

- 9(2)(a) to protect the privacy of individuals
- 9(2)(b)(ii) to protect commercially confidential information
- 9(2)(c) to protect the health and safety of members of the public
- 9(2)(f)(iv) to maintain the confidentiality of advice tendered by Ministers of the Crown and officials
- 9(2)(g)(i) to maintain the effective conduct of public affairs through the free and frank expression of opinions
- and 9(2)(i) and 9(2)(j) to enable the Ministry to carry on without prejudice or disadvantage, commercial activities and negotiations.

Some information requested was also refused in the original responses under section 18(d) as it is publicly available.

Oranga Tamariki intends to make the information contained in this letter and any attached documents available to the wider public shortly. We will do this by publishing this letter and attachments on our website. Your personal details will be deleted and we will not publish any information that would identify you as the person who requested the information.
