Official Information Act 1982 request

I am replying to your email of 24 March 2014 in which you have requested information about drink driving offences in the Southland and Central Otago region from 2011 to 2013.

Please note a person may have more than one drink driving conviction in a year, which will not be shown in this data. Only a person's most serious charge will be included.

The Southland and Central Otago region includes courts in Alexandra, Gore, Invercargill and Queenstown.
