Thank you for your email.

A number of people, including the Mayor of Wellington and our legal advisers have "highly recommended" Dunning Thornton as the best engineers for this particular job. This also included the engineer who is on the Board of St Gerard's Maintenance and Restoration Trust.

We did also spend time with a 3rd engineering firm, They came twice to St Gerard's for some hours with an alternative proposal based on "base isolators", but it was determined that, although that is a option for the church (and Dunning Thornton will look at that option as part of the work they are doing), it was impractical for the monastery.

For those reasons we agreed not to get a further quote, bearing in mind that the 1st assessment was done by Clendon, Burns and Park who also have a reputation in this field. These two firms are regarded as the best in Wellington when it comes to seismic strengthening, particularly for large buildings. Accordingly it was agreed that we would chose the only other "highly recommended" seismic engineering firm to undertake this 2nd assessment.

In short we have chosen the most highly recommended and experienced seismic engineers in Wellington. We need to say also that there is no agreement amongst engineers when it comes to seismic strengthening and every building is different in its construction etc.

We trust that you will accept that the quote from Dunning Thornton is, to all intends and purposes, a 2nd quote having regard to the foregoing.
